BARBARA MALE SARGENT, WIFE OF RICHARD C. SARGENT, JR., LAST SPRING WAS ELECTED VICE-CHAIRMAN OF THE REPUBLICAN TOWN COMMITTEE OF TRUMBULL, CONN. WE STARTED MONTHS AGO GETTING NEW VOTERS MADE, LINING UP THOSE WHO NEEDED ABSENTEE BALLOTS. NEAR THE BIG DAY, WE SENT OUT EDUCATIONAL LITERATURE ABOUT CORRECT MARKING OF THE PAPER BALLOTS, WHICH HELPED CUT DOWN THE REJECTIONS. THE OVER-ALL RESULTS OF THE ELECTION WERE GRATIFYING TO ME, AS I KNOW THEY WERE TO MANY OTHERS. I FELT THAT WE WERE SPENDING AND TAXING OUR WAY TOWARDS SOCIALISM, AND I'M EXTREMELY HOPEFUL THAT THE GOOD OLD AMERICAN IDEAS OF FREEDOM AND OPPORTUNITY WILL SUPPLANT THE HUE AND CRY FOR HAND-OUTS AND 'SECURITY' FROM THE GOVERNMENT."

JAMES C. SARGENT, SON OF MURRAY SARGENT, WHO HAS BEEN WORKING SINCE HIS RETURN FROM THE ARMED FORCES IN 1945 TO DEFEAT VITO MARCANTONIO, THE PRO-COMMUNIST CONGRESSMAN FROM THE 18TH CONGRESSION-AL DISTRICT IN NEW YORK, RELATED THE FOLLOWING INCIDENT IN THE RECENT ELECTION WHERE THE CONGRESSMAN WAS FINALLY DEFEATED. "IN THE LATTER PART OF SEPTEMBER I WAS ASKED TO SERVE AS A SPECIAL ASSISTANT ATTORNEY GENERAL IN THE ELECTION FRAUDS BUREAU OF THE (NEW YORK) ATTORNEY GENERAL'S OFFICE. KNOWING FROM MY PAST EXPERIENCE THAT FRAUDS IN THE 18TH CONGRESSIONAL DISTRICT DID EXIST, I ATTEMPTED TO DE-VOTE PART OF MY EFFORTS TO THIS DISTRICT IN AS IMPARTIAL A FASHION AS I POSSIBLY COULD. ALTHOUGH I AM A REPUBLICAN DISTRICT CAPTAIN IN THE 2D ELECTION DISTRICT OF THE 10TH ASSEMBLY DISTRICT OF THE 18TH CONGRESSICNAL DISTRICT, I DID NOT CANVASS ANY OF THE VOTERS NOR DID I SERVE IN THIS CAPACITY EITHER DURING REGISTRATION OR ON ELECTION DAY. I TURNED OVER MY DUTIES AS A CAPTAIN TO OTHERS INCLUDING MY BROTHERS HENRY AND JOHN. ON ELECTION DAY AN INCIDENT OCCURRED WHICH I THINK MIGHT BE OF INTEREST TO YOU AND THE READERS OF SARGENTRIVIA. THE NIGHT BEFORE ELECTION I DID NOT GO TO BED AT ALL. AT 5 A.M. 1 OPENED THE ELECTION FRAUDS BUREAU OFFICE, AND AT 5:30 A.M., ACCOMPANIED BY HAZARD GILLESPIE, A NEW YORK LAWYER AND A GRADUATE OF YALE COLLEGE AND YALE LAW SCHOOL, I LEFT THE NEW YORK STATE BUILDING IN A POLICE CAR. WITH US WE HAD SOME 300 LETTERS WHICH HAD BEEN SENT OUT BY JAMES DONOVAN, THE COALITION CANDIDATE FOR CONGRESS IN OPPOSITION TO VITO MARCANTONIO. WE WENT TO EACH POLLING PLACE IN THE 16TH ASSEMBLY DISTRICT-THIS IS THE NORTHERN PORTION OF THE 18TH CONGRESSIONAL DISTRICT AND IS THE DISTRICT FROM WHICH MARCANTONIO IN THE PAST HAS RECEIVED THE GREATEST PORTION OF HIS SUPPORT. THESE 300 LETTERS HAD ALL BEEN RETURNED BY THE POST OFFICE STAMPED WITH A RED STAMP STATING THAT NO SUCH PERSON LIVED AT THAT ADDRESS. TO US THIS INDICATED, PRIMA FACIE AT LEAST, THE ABSENCE OF THE NECESSARY RESIGENTIAL REQUIREMENTS FOR VOTING. IN EACH DISTRICT WE REQUESTED THE BOARD REGISTRY INSPECTORS TO CHALLENGE THE PERSONS NAMED ON THESE LETTERS. IN SEVERAL CASES WE WERE ACCUSED BY SOME OF THE A.L.P. SUPPORTERS OF EVERYTHING FROM ELECTIONEERING TO DECEIT. NEVERTHELESS WE PRESSED OUR POINT AND SUCCEEDED IN APPROACHING EVERY DISTRICT. WHILE ON THIS MISSION WE RECEIVED A CALL OVER THE POLICE RADIO: 'CAR 81 CALL YOUR OFFICE'. SINCE PATROLMEN OR POLICE REPRESENTATIVES ARE SUMMONED OVER THE AIR BY CALL YOUR PRECINCT', WE KNEW THAT THE ATTORNEY GENERAL'S ELECTION FRAUDS BUREAU WANTED US. | CALLED THE OFFICE AND WAS TOLD THAT A FRAUDULENT VOTING MACHINE HAD BEEN LOCATED BY MARCANTONIC IN A STORE DIRECTLY

ACROSS FROM THE POLLING PLACE ON 119TH STREET. WE WENT TO THIS LOCATION IMMEDIATELY AND FOUND A STORE FRONT COVERED WITH MARCANTONIO'S POSTERS. INSIDE WAS A VOTING MACHINE WHICH WAS TO BE USED BY MARCANTONIO TO EDUCATE HIS CONSTITUENTS BEFORE THEY VOTED ACROSS THE STREET. THE ELECTION LAW STATES THAT NO ELECTIONEERING CAN TAKE PLACE WITHIN 100 FEET IN A PUBLIC STREET AND NO ELECTIONEERING WITHIN THAT DISTANCE IN A PRIVATE PLACE IN A PUBLIC MANNER. I TOLD SEVERAL POLICEMEN TO TAKE DOWN THE FOST-ERS AND TO PREVENT THE USE OF THIS VOTING MACHINE IN A PUBLIC MANNER. ABOUT THIS TIME MARCANTONIO, FOLLOWED BY A WHOLE CARLOAD OF REPORTERS FROM THE VARIOUS NEW YORK NEWSPAPERS, CAME ONTO THE SCENE. MARCANTONIO, WHO PRESENTS AT BEST A SOMEWHAT DESPICABLE APPEARANCE, RUSHED IN, TOOK ONE LOOK AT ME AND WITH A CONTEMPTUOUS SNEER SAID 'WHY THAT IS JIM SARGENT FROM THE NEW YORK YOUNG REPUBLICAN CLUB. THAT CLUB HAS BEEN FIGHTING ME FOR THE PAST TEN YEARS AND HAS TRIED IN ALL THOSE YEARS TO DEFEAT ME. I CHARGE THE ATTORNEY GENERAL WITH A DELIBERATE PARTISAN, POLITICAL ATTEMPT TO DISCREDIT ME AND YOU CAN QUOTE ME. ' THE PENCIL PUSHERS FROM THE VARIOUS NEWSPAPERS STARTED TO WORK. FORTUNATELY, SINCE THE ATTORNEY GENERAL ABHORS PUBLICITY FOR ANYONE BUT HIMSELF, MY NAME HAD ESCAPED THEM. I SAID TO MARCANTONIO THAT HE WAS 'DELIBERATELY TWISTING FACTS' AND THAT 'IN FACT THE VERY PRESENCE OF POLITICAL POSTERS ON THE FACE OF THIS STORE AND THE USE OF THIS VOTING MACHINE IN A PUBLIC MANNER CONSTITUTED A CLEAR VIOLATION OF THE ELECTION LAW'. HE THEN SAID 'ALL RIGHT, I AM GOING INTO THIS STORE AND I PERSONALLY SHALL INSTRUCT PERSONS IN THE USE OF THESE VOTING MACHINES. A DETECTIVE JUMPED IN AND SAID 'OH, NO YOU DON'T.' MARCANTONIO REPLIED 'ALL RIGHT, LOCK ME UP'. OF COURSE THAT IS WHAT HE WANTED, BUT DID NOT GET. I THEN SAID 'IF HE INSTRUCTS IN A PURELY PRIVATE WAY WITHOUT PUBLIC NOTICES THERE IS NO VIOLATION OF THE ELECTION LAW'. WHEN I WAS THEN ASKED FOR MY NAME I DECLINED WITH THE WORDS "SKIP IT". MARCANTONIO THEN CHIMED IN WITH THE SAME WORDS, AND THE INCIDENT FOR THE MOMENT WAS CLOSED. SUBSEQUENTLY THE BOARD OF ELECTIONS CLOSED DOWN THIS 'HALL' OR 'STORE' BECAUSE THE USE OF A VOTING MACHINE FOR EDUCATIONAL PURPOSES THEREIN VIOLATED ONE OF ITS DIRECTIVES TO THE EFFECT THAT SUCH VOTING MACHINES (ALL VOTING MACHINES USED IN AN ELECTION ARE RENTED FROM THE MANUFACTURING COMPANY IN JAMESTOWN, N.Y.) CAN ONLY BE USED IN REGULAR AUTHORIZED CLUB HOUSES. THIS FACT WAS NOT MENTIONED IN ANY OF THE NEWSPAPER ARTICLES I SAW."

'THE BIG THING THAT I WOULD STRESS', PUT IN TAYLOR, 'IS THE SCIENTIFIC APPROACH TO ALL BUSINESS PROBLEMS. IN THIS COUNTRY STATISTICS GOVERN ALMOST EVERY THING INDUSTRY DOES. NOT ONLY THE MANUFACTURING PROCESSES, BUT THE BOOKKEEPING, THE ACCOUNTING METHODS, THE LABORATORY EXPERIMENTS, THE HUMAN RELATIONS IN THE PLANT, EVEN THE SALES TECHNIQUES ARE CAREFULLY DOCUMENTED, TESTED, AND REPORTED. WE HAVE NOTHING LIKE THE CAREFUL PROGRAMS WORKED OUT BY SARGENT AND OTHER EMPLOYERS TO BENEFIT THEIR WORKERS, COMMENTED TAYLOR. AND I HAVE SEEN LITTLE IN FRANCE TO DUPLICATE THE SENSE OF COMMUNITY RELATIONS AND COMMUNITY RESPONSIBILITY THAT WE HAVE SEEN HERE IN THE SARGENT FACTORY. HERE THE COMPANY AND ITS WORKERS SEEM TO SHARE A RESPONSIBILITY THAT GOES BE-YOND THE FACTORY GATES AND CONTRIBUTES ACTIVELY TO THE WELFARE OF ALL THIS CITY OF NEW HAVEN. * THEIR NINE-MONTH MISSION IS COMPLETED THE 21 YOUNG FRENCHMEN WILL RETURN TO FRANCE TO A TWO-FOLD TASK. FIRST THEY WILL ATTEMPT TO APPLY THEIR IDEAS AND OBSERVATIONS TO THE INDIVIDUAL INDUSTRY IN WHICH THEY WORK. SECONDLY, THEY WILL ADVOCATE, EXPLAIN, AND ADAPT, WHEREVER FRENCH PLANTS CAN USE THEM, THE METHODS THAT KEEP U. S. PRODUCTIVITY HIGH. THREE-WAY SOLUTION THE FRENCH VISITORS FEEL THAT THEY MUST "SELL" THREE BASIC IDEAS WHEN THEY REACH HOME. THEY ARE CONVINCED THAT A CUSTOMS POOL MUST BE WORKED OUT IN WEST EUROPE SO THAT FRANCE WILL HAVE A LARGE AND HEALTHY MARKET FOR HER MANUFACTURED GOODS. SECOND, THEY FEEL THAT THE AMERICAN CONCEPT OF HUMAN RELATIONSHIPS IN INDUSTRY MUST BE ADAPTED BY THE FRENCH ON AS FULL A SCALE AS POSSIBLE. THIRDLY, THEY HOPE TO PROMOTE THE USE OF OUR SPECIAL TECHNIQUES-STATISTICAL CONTROLS, LONG-RANGE PLANNING, INDUSTRIAL PSYCHOLOGY - THROUGHOUT FRANCE."

THOMAS GIFFARD (1408-1469), ANCESTOR OF MOST OF US (SEE GENEALOGICAL CHART IN SARGENTRIVIA OF MAY 25, 1949), WAS BORN IN FRINGFORD, COUNTY OF OXFORD, ENGLAND, THE SON OF ROGER AND HIS THIRD WIFE ISABEL STRETELE. HIS FATHER DIED IN 1409 WHEN HE WAS A LITTLE MORE THAN A YEAR OLD. HIS MOTHER MARRIED SECONDLY JOHN STOKES OF TWYFORD. OCTOBER 21, 1409, THE KING'S KINSMAN, WILLIAM, LORD ROOS OF HAMLAK WAS GRANTED CUSTODY OF THE YOUNG HEIR. LORD ROOS DIED IN 1414, AND MAY 3, 1415, CUSTODY OF THE HEIR WAS GRANTED TO THOMAS, DUKE OF CLARENCE, WHO WAS KILLED IN THE BATTLE OF BEAUGE IN 1420. IN TRINITY TERM, 1415, THOMAS GIFFARD, BY WILLIAM ROKESBURGH, HIS GUARDIAN, BROUGHT SUIT AGAINST HIS STEPFATHER AND MOTHER, JOHN AND ISABEL STOKES, TO RECOVER THE MANOR OF HELYDON, UNDER THE SETTLEMENT MADE MARCH 8, 1361, BY HIS GREAT-GRANDFATHER, SIR JOHN GIFFARD, AND IT WAS AGREED THAT THOMAS SHOULD RECOVER HIS SEISIN (I.E. POSSESSION) OF THIS MANOR. THE MANOR AT FRINGFORD CAME TO HIM AFTER THE DEATH OF SYBIL, HIS STEPGRANDMOTHER, WHO DIED FEBRUARY 26, 1428/9. HE MARRIED ELEANOR VAUX, DAUGHTER OF WILLIAM, ESQ., ANCESTOR OF THE LORDS VAUX OF HARROWDEN, CO. NORTHAMPTON. ON FEBRUARY 5, 1429/30, THOMAS GIFFARD AND HIS STEPFATHER, JOHN STOKES, GAVE A BOND FOR \$200 TO THOMAS CHAUMBRE, ESQ., WILLIAM VAUX, ESQ., AND THOMAS TRESHAM, TO PERMIT ELEANOR, DAUGHTER OF WILLIAM VAUX, ESQ., DECEASED, TO HAVE SUFFICIENT ESTATE FOR HER LIFE IN THE MANORS OF ASTWELL AND HELYDON IN NORTHAMPTONSHIRE AND IN CERTAIN LANDS, ETC., IN ASTWELL AND HELYDON AND IN WATER STRATFORD, CO. BUCKS -- APPARENTLY A MARRIAGE SETTLEMENT. IN 1434 HE WAS ONE OF THOSE WHO WERE REQUIRED TO JAKE OATH NOT TO MAINTAIN LAW-BREAKERS, AND IN 1439 HE WAS COM-MISSIONED TO INVESTIGATE THE ESCAPES OF FELONS IN CO. BUCKS. HE APPEARS TO HAVE BEEN A YORKIST, AS HE BEGAN TO HOLD LOCAL OFFICES IN BUCKS UPON THE VICTORY OF EDWARD IV AT TOWTON IN 1461. HE WAS A COM-MISSIONER OF PEACE AND ARRAY IN BUCKS IN 1460-1464 AND 1466. AT HIS DEATH, MAY 28, 1469 (NOT 1460 AS INCORRECTLY GIVEN IN SARGENTRIVIA CHART), HE HELD TWYFORD. HE HAD A SON, JOHN, OUR ANCESTOR, AND A DAUGHTER, ELIZABETH. (THE ABOVE INFORMATION IS FROM N.E. HISTORICAL & GENEALOGICAL REGISTER, VOL. 75, 1921.)
