MARGARET SARGENT FISHER, DAUGHTER OF ROBERT LEWIS FISHER AND OF ATLEE DOWNS FISHER, WAS MARRIED AT 6 P.M. ON MAY 23D AT THE HOME OF MR. AND MRS. HUGH MATHESON, JR., MIAMI, FLORIDA, TO OISTEIN LIE-NIELSEN, A NORWEGIAN BY BIRTH BUT A NATURALIZED AMERICAN CITIZEN. IT WAS A CIVIL CEREMONY PERFORMED BY JUDGE WILLIAM HERRIN OF DADE COUNTY. MR. & MRS. ALLAN CARLISLE (HER SCREEN NAME IS KARIN BOOTH) WERE BEST MAN AND ATTENDANT RESPECTIVELY. THE BRIDE WAS GIVEN AWAY BY MR. JACK CURTIS OF CAMDEN, MAINE, AND WORE A WHITE LINEN SUIT WITH NAVY BLUE ACCESSORIES AND CARRIED A BOUQUET OF AMERICAN BEAUTY ROSES WITH SPRAYS OF BABY'S BREATH. MR. AND MRS. MATHESON GAVE THE BRIDAL COUPLE A SMALL COCKTAIL PARTY AFTERWARDS "COMPLETE WITH WEDDING CAKE AND ALL". THE HONEYMOON WAS SPENT IN MARATHON AND KEY WEST. THE BRIDE IS A GRANDDAUGHTER OF SAMUEL H. FISHER OF LITCHFIELD AND THE LATE MARGARET SARGENT FISHER AND OF MRS. NORTON DOWNS OF PHILADELPHIA AND THE LATE DR. DOWNS. SHE SERVED IN THE U.S. MARINES DURING THE WAR. SOME OF HER LETTERS DURING THAT PERIOD APPEARED IN SARGENTRIVIA. LEE CAME FROM OSLO TO THIS COUNTRY TWENTY-FOUR YEARS AGO WHEN HE WAS EIGHTEEN. IN HIS EARLY TWENTIES HE WENT INTO THE LOBSTER BUSINESS IN BOSTON. AT THE BEGINNING OF WORLD WAR II HE HAD A SUCCESSFUL LUMBER BUSINESS IN GEORGIA. HE HAS SEVERAL CHILDREN. MAGGIE, AS SHE IS CALLED BY MOST OF HER INTIMATES, WROTE TO YE EDITOR ON JUNE 1ST: "HE IS A GRADUATE OF THE BUSINESS COLLEGE OF OSLO, NORWAY, IS A MEMBER OF THE ROYAL NORWEGIAN YACHT CLUB; HAS BEEN A SEA-FARING MAN ALL HIS LIFE, AND BETWEEN BUSINESSES WAS CAPTAIN OF NUMEROUS TWO AND THREE-MASTED SCHOONERS AND MATE ON THE SQUARE-RIGGER, 'THE SEVEN SEAS'. IN 1928 HE WAS DECORATED BY THE FORMER PRESIDENT OF NICARAGUA, MONCADA, WITH THE NICARAGUAN MEDAL OF HONOR DURING THE SECOND NICARAGUAN CAMPAIGN, DURING WHICH LEE SERVED FOR TWO YEARS IN THE UNITED STATES MARINE CORPS. HE DID NOT SERVE IN EITHER OF THE WORLD WARS, AS HE WAS TOO YOUNG FOR THE FIRST AND THEY WOULDN'T TAKE HIM IN THE SECOND AS HE WAS IN THE LUMBER BUSINESS, WHICH WAS 'ESSENTIAL WORK' AT THAT TIME. * * * AT THE MOMENT WE ARE LIVING IN A FURNISHED EFFICIENCY APARTMENT AT 3453 S.W. 23D TERRACE, MIAMI, FLORIDA, BUT WILL ONLY BE THERE UNTIL WE GO NORTH FOR THE SUMMER. WE HOPE TO BE SETTLED SOMEWHERE THIS FALL AT WHICH TIME LEE PLANS TO GO INTO THE PULPWOOD BUSINESS. FOR THE SUMMER HE WILL BE CAPTAIN OF MR. CARLISLE'S 72 FT. KETCH 'TICONDEROGA' CRUISING IN THE NEW ENGLAND WATERS. I WILL PROBABLY SAIL NORTH WITH THEM, BUT SPEND THE SUMMER FOLLOWING THE BOAT AROUND FROM PORT TO PORT ON LAND."

MARY DWIGHT PULFORD, STEPDAUGHTER OF CATHERINE RICE PULFORD, IS ENGAGED TO BE MARRIED TO CHARLES NICHOLS GREGORY, JR., SON OF MRS. GREGORY OF WEST HARTFORD AND THE LATE MR. GREGORY. THE ENGAGEMENT WAS ANNOUNCED ON MAY 5TH. MARY IS A GRADUATE OF CHAFFEE SCHOOL AND SKIDMORE COLLEGE. SHE STUDIED AT THE HARTFORD ART SCHOOL AND IS NOW ATTENDING THE ART STUDENTS LEAGUE IN NEW YORK CITY. SHE IS A MEMBER OF THE COTILLION CLUB OF HARTFORD. MARY RECENTLY HAD A "ONE MAN" SHOW AT THE STUDIO CLUB IN NEW YORK. CHUCK LIVED IN NEW HAVEN DURING THE LAST YEARS OF HIS FATHER'S LIFE AND ATTENDED HOPKINS GRAMMAR SCHOOL. JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR'S GENERATION, WROTE THE FOLLOWING LETTER FROM NEW HAVEN TO HIS WIFE, WHO WAS CONVALESCING IN DR. WARD'S PRIVATE HOSPITAL IN NEW YORK. "FANNIE" IN THE LETTER REFERRED TO HER SISTER, MRS. JUSTUS S. HOTCHKISS. THE BUILDING REFERRED TO WAS BUILDING S OF SARGENT & COMPANY OF FIVE STORIES AND BASEMENT, PRIMARILY FOR THE MANUFACTURE OF LOCKS, A NEW PRODUCT. "OCT. 21/84 DEAR FLORENCE: I SEND LETTER OF MRS. JULIA W. HOWE WHICH I OPENED AND ANSWERED. ALSO A LETTER FROM FANNIE. WE HAVE WEDDING CARDS FROM MRS. & MRS. WINSTON J. TROWBRIDGE, LEXINGTON, KY., MR. & MRS. JAMES REA (MISS ELIZABETH S. HAGUE) WHICH I SAVE FOR YOU. I HAVE YOUR LETTER ASKING FOR GAS STOVE, TIN BOX OF BREAD AND GRAPES. I SENT LAST OF THE GRAPES YESTERDAY. WHEN YOU BEGIN TO CONVALESCCE CONSIDERABLY I DON'T WANT TO BOARD YOU AT A A-LA-CARTE HOTEL. BUSINESS IS NOT SUFFICIENTLY GOOD FOR THAT. YOU WILL WANT A STEAM BOILER AND STEAM ENGINE TO COOK AND CUT YOUR HASH AND POUND YOUR BEEFSTEAKS - YOU WILL NOT WANT A GAS STOVE IN YOUR ROOM BUT A COOKING RANGE AND A BUTLERS PANTRY AND STORE ROOM. HOW LONG TO YOU INTEND TO WANT A GAS STOVE IN YOUR ROOM? I DO NOT THINK HIGHLY OF COOKING BY A GAS STOVE IN A SICKROOM. I HAVE GOT TO GO TOMORROW EVENING TO FAIR HAVEN TO EXPLAIN FREE TRADE TO THE PEOPLE WHO WANT TO LEARN ABOUT IT. I HAVE NOT HEARD FROM UNIONVILLE YET. MR. & MRS. MCCREA LEFT FOR CHICAGO TODAY. MR. MC SAID HE WAS VERY SORRY NOT TO SEE YOU, AND ESPECIALLY SORRY THAT HIS WIFE COULD NOT SEE YOU AS HE HAD SPOKEN SO OFTEN TO HER OF YOU. (TAFKY) NORTH CHURCH HAS HAD LEAVE TO WITHDRAW ITS PETITION FOR MORE LAND ON THE GREEN; THAT IS, LAND IS REFUSED BY THE COMMON COUNCIL. ANOTHER SPLENDID DAY TODAY (TUESDAY) FOR BUILDING AND WE HAVE IMPROVED IT. FIVE STORIES FINISHED WALLS AND PART OF THE 6TH STORY FLOOR BEAMS ON. ALL WELL - EVERYTHING AS USUAL. YOURS AFFECTIONATELY, J. B. SARGENT"

ANDREW SANFORD (1617-1684), IMMIGRANT ANCESTOR OF MOST OF US, WAS THE FATHER OF THE ANDREW SANFORD IN THE GENEALOGICAL CHART OF THE ANCESTRY OF CHLOE CAROLINE ROBINSON COLLIER IN SARGENTRIVIA OF MARCH 20, 1951. HE WAS BORN IN 1617 IN STANSTEAD, MOUNTFITCHET, COUNTY OF ESSEX, ENGLAND, THE SON OF ESECHIELL, GRANDSON OF THOMAS AND GREAT GRANDSON OF RICHARD SANFORD (D. 1591). THE FIRST RECORD OF ANDREW SANFORD IN HARTFORD WAS IN 1651. HE WAS MADE A FREEMAN ON MAY 21, 1657, AND WAS CHIMNEY VIEWER IN JUNE 1662. HIS FIRST WIFE, MARY, WAS THE MOTHER OF ANDREW, JR. IN JUNE 1662 ANDREW AND MARY SANFORD WERE BOTH INDICTED FOR WITCHCRAFT, A CAPITAL OFFENSE. THE RECORDS OF THE PARTICULAR COURT OF CONNECTICUT SHOW THE FOLLOWING ABOUT ANDREW SANFORD UNDER THE HEADING "THE INDITEMTS OF ANDREW ET MARY SANFORD":

"ANDREW SANFORD THOU ART HERE INDITED BY THE NAME OF ANDREW SANFORD FOR NOT HAUEING THE FEARE OF GOD BEFORE THINE EYES THOU HAST ENTERTEINED FAMILIARITY WTH SATAN THE GRAND ENEMY OF GOD AND MANKIND AND BY HIS HELP HAST ACTED THINGS IN A PRETERNATURALL WAY BEYOND THE COURSE OF NATURE TO YE GREAT PREJUDICE OF YE COMFORTS OF SEVERALL MEMBERS OF THIS COMON WEALTH FOR WCH ACCORDING TO YE LAW OF GOD AND ESTABLISHED LAW OF THIS COLONY THOU DESERUEST TO DIE.

"THE JURY RETURNE THEY CANNOT AGREE SOME FIND INDITEMENT AGAINST SANFORD THE REST STRONGLY SUSPECT."

THE RECORD WHICH FOLLOWS OF MARY SANFORD'S TRIAL SHOWS THE NAMES OF THE MAGISTRATES AND OF THE JURY ("THO WELLS" WAS UNDOUBTEDLY OUR ANCESTOR, A SON OF THE GOVERNOR):

WILLM HEYDEN JOHN BISSELL SAMLL WELLS JOHN KILBURN ANTHONY HOWKINS BENEDICT ALVARD.

THE INDITEMT OF MARY SANFORD

MARY SANFORD THOU ART HERE INDITED BY THE NAME OF MARY SANFORD THE WIFE OF ANDREW SANFORD FOR NOT HAUEING THE FEARE OF GOD BEFORE THYNE EYES THOU HAST ENTERTEINED FAMILIARITY WTH SATAN THE GREAT ENEMY OF GOD AND MANKIND AND BY HIS HELP HAST ACTED AND ALSO HAST COME TO YE KNOWLEDG OF SECRETS IN A PRETERNATURALL WAY BEYOND THE ORDINARY COURSE OF NATURE TO YE GREAT DISTURBANCE OF SEVERALL MEMBERS OF THIS COMON WEALTH FOR WCH ACCORDING TO YE LAW OF GOD AND YE ESTABLISHED LAW OF THIS COLONY THOU DESERUEST TO DIE.

VERDICT.

RESPECTING MARY SANFORD THE PRISONER AT YE BARR YE JURY FIND HER GUILTY OF YE INDITEMENT."

MARY SANFORD WITHOUT MUCH DOUBT WAS EXECUTED, AT ANY RATE SHE DIED IN 1662. ANDREW SANFORD MOVED TO MILFORD, CONN., IN 1667 AND ABOUT THAT TIME MARRIED SECONDLY SARAH GIBBARD (DAUGHTER OF WILLIAM OF NEW HAVEN). HE AND HIS SECOND WIFE JOINED THE MILFORD CHURCH MARCH 4, 1671. HE DIED IN MILFORD IN 1684. HIS WILL IS DATED SEPTEMBER 6, 1684, AND THE INVENTORY OF HIS ESTATE OCTOBER 16, 1684. AT THE LEFT IS A FACSIMILE OF A SUBTITLE PAGE IN A BOOKLET (7 1/2 x 4 1/2 INCHES) WITH STIFF BLACK COVERS OF 104 PAGES (INCLUDING THE COVERS), THE GILT LETTERING (NOW A BIT FADED) ON THE FRONT COVER READING: "PRICE LIST OF HARDWARE MANUFACTURED AND SOLD BY THE PECK & WALTER MANUFACTURING CO. NEW BRITAIN, CONN. AND SARGENT, BROTHER & CO. WAREHOUSE 85 BEEKMAN ST., NEW YORK. 1855. PRESS OF CASE, (REST OF NAME ILLEGIBLE.-ED.)" ON THE TITLE PAGE IS THE STATEMENT: "THE BUSINESS AT NEW YORK IS CONFIDED TO J.B. SARGENT, A MEMBER OF THE COMPANY".

ALTHOUGH THE ONLY ILLUSTRATION IN THE BOOKLET IS A DRAWING SHOWING MOLASSES FLOWING FROM A BARREL THROUGH A MOLASSES GATE INTO A PITCHER, THE PAGES THROW LIGHT ON EARLY SARGENT BUSINESS HISTORY. THE PRODUCTS OF THE PECK & WALTER MANUFACTURING CO. ARE LISTED THROUGH PAGE 50. (BOXWOOD AND IVORY RULES ON PAGES 44 TO 48, HOWEVER, ARE STATED AS "MANUFACTURED BY A. STANLEY & CO.") IN THE LAST HALF OF THE BOOKLET ARE LISTED PRODUCTS OF OTHER MANUFACTURERS, AND YE EDITOR BELIEVES COVER THE PRODUCTS OF ALL THE CONCERNS FOR WHOM SARGENT, BROTHER & CO. WERE AT THAT TIME SELLING AGENTS. SOON AFTER GEORGE H. SARGENT (1828-1917) JOINED HIS BROTHER, JOSEPH B. SARGENT (1822-1907), IN NEW YORK, THE FIRM WAS CALLED SARGENT, BROTHER & CO. AS "G.H." SAID, "THERE WAS NO 'CO.', BUT IT LOOKED BETTER AND SOUNDED BETTER THAT WAY." IN 1858, WHEN BROTHER EDWARD SARGENT (1833-1883) BECAME A THIRD PARTNER, THE FIRM NAME WAS SARGENT & CO. "J.B." STARTED THIS SALES BUSINESS IN 1849 AT 24 CLIFF STREET AND MOVED MAY 1, 1854, TO 85 BEEKMAN STREET.

ON THE LAST FOUR PAGES OF THE BOOKLET ARE LISTED THE PRODUCTS OF SARGENT & BROTHER (OF LEICESTER, MASS.), PRECEDED BY THE SUBTITLE PAGE ILLUSTRATED HERE. AT THAT TIME THE PARTNERS IN THIS FIRM WERE JOSEPH B. SARGENT (1822-1907) AND EDWARD SARGENT (1833-1883). GEORGE H. SARGENT (1828-1917) PURCHASED FROM HIS BROTHERS A ONE-THIRD INTEREST IN 1858. "MINERAL AND PORCELAIN DOOR, SHUTTER AND DRAWER KNOBS" ON THE SUBTITLE PAGE ARE NOT MENTIONED ON THE FOUR FOLLOWING PAGES ON WHICH THE PRODUCTS ARE LISTED AND PRICED. LESS THAN TWO PAGES ARE DEVOTED TO CARDS (I.E. HAND CARDS). THERE ARE 13 ITEMS OF COTTON CARDS LISTED WITH A PRICE RANGE FROM \$2.12 1/2 TO \$3.00. WOOL CARDS RANGE FROM \$1.37 1/2 TO \$2.12 1/2 (7 ITEMS). JIM CROW CARDS, HORSE CARDS AND CURRY CARDS ARE EACH OFFERED IN THREE VARIETIES: "BRASS", "COP'D" AND "IRON". THEN FOLLOWS THE FOLLOWING NOTATION: "THE CARDS DIS-

TINGUISHED BY THE LETTER 'A' (ON THE BOX) ARE KNOWN AS THE 'SARGENT' CARDS, AND ARE SUPERIOR TO ANY OTHERS MADE. THOSE DISTINGUISHED BY OTHER LETTERS ARE THE 'WHITTEMORE' CARDS AND ARE FULLY EQUAL TO OTHER CARDS OF THAT STAMP." SARGENTRIVIA OF OCTOBER 25, 1950, CONTAINED AN ACCOUNT OF THE WHITTEMORE PURCHASE AND THE SUBSEQUENT USE OF THE NAME. OF THE OTHER PRODUCTS LISTED YE EDITOR DOES NOT KNOW WHAT THE GAROTE RAT TRAP LOOKED LIKE, IN FACT DID NOT KNOW UNTIL HE EXAMINED THIS PRICE LIST THAT EITHER OF THE SARGENT FACTORIES EVER MANUFACTURED ANY KIND OF A RAT TRAP, THOUGH THE NEW YORK SALES FIRM FOR YEARS SOLD BOTH RAT AND MOUSE TRAPS. PERHAPS THEY WERE MADE ORIGINALLY FOR USE AT THE FACTORY IN AN ENDEAVOR TO KEEP DOWN THE RODENT POPULATION, A SERIOUS PROBLEM WHERE HORSES WERE STABLED. HIS EARLY BUSINESS EXPERIENCES AS TOLD BY GEORGE H. SARGENT (1828-1917) APPEARED IN SARGENTRIVIA OF MAY 25, 1944. THE PARTNERSHIP AGREEMENTS, DATED DECEMBER 1, 1858, OF SARGENT & CO. AND OF SARGENT & BROTHER WERE SHOWN IN OUR ISSUES OF FEBRUARY 23, 1945, AND JULY 26, 1948, RESPECTIVELY. A PICTURE OF THE LEICESTER PLANT WAS IN OUR ISSUE OF JUNE 26, 1950. THE PECK & WALTER MANUFACTURING CO. NOT LONG AFTER THE DATE OF THIS PRICE LIST WAS ACQUIRED BY THE SARGENTS, AND WHEN THE MANUFACTURING WAS MOVED TO NEW HAVEN IN 1864 IT WAS INCORPORATED AS SARGENT & COMPANY.
