THE BRIDESMAIDS WERE HELEN BALLANGER HUTTON, OF NEW HAVEN, SISTER-IN-LAW OF THE BRIDE, MISS JANE HEALEY OF ORANGE, MRS. CHARLES T. STURGESS OF PINE ORCHARD AND MRS. WESLEY B. VANBENSCHOTEN OF POUGHKEEPSIE, N.Y. PAMELA HUTTON FABIAN, NIECE OF THE BRIDE, WAS FLOWER GIRL. THE BRIDE WORE A GOWN OF CHAMPAGNE AND IVORY TULLE OVER SATIN WITH A BOUFFANT SKIRT AND BERTHA OF HEIRLOOM LACE. A RECEPTION WAS HELD AT THE NEW HAVEN LAWN CLUB. THE BRIDE'S MOTHER RECEIVED IN A HAZEL LACE AND CHIFFON GOWN WITH A MATCHING TULLE HAT AND A CORSAGE OF HAZEL CAMELLIAS. THE BRIDEGROOM'S MOTHER WORE AN ORCHID-PINK LACE GOWN TRIMMED WITH PLUM VELVET, A MATCHING HAT, AND A CORSAGE OF CYPRIPEDIUM ORCHIDS. THERE WAS A BRIEF SHOWER AN HOUR BEFORE THE WEDDING AND ANOTHER DURING THE RECEPTION, BUT THERE WAS NO RAIN WHEN THE BRIDAL COUPLE LEFT FOR THEIR HONEYMOON, TO BE SPENT IN BERMUDA. ELBERT CHARLES COLE, WERE MARRIED AT FOUR O'CLOCK ON SATURDAY, JUNE 23D, IN THE FIRST CONGREGATIONAL CHURCH IN WILLIAMSTOWN, MASS. THE REVEREND GEORGE E. SEILBY, PASTOR, PERFORMED THE DOUBLE RING CEREMONY. THE CHURCH WAS DECORATED WITH PINK RAMBLER ROSES. A RECEPTION WAS HELD AT THE FACULTY HOUSE, WILLIAMS COLLEGE. THE BRIDE'S MOTHER WORE AN AQUAMARINE SHEER AFTERNOON DRESS WITH BLACK ACCESSORIES AND A CORSAGE OF TALISMAN ROSES. THE GROOM'S

MOTHER WORE A NAVY BLUE SHEER DRESS WITH A ROSE COLOR STRAW HAT AND A CORSAGE OF PINK SWEET PEAS. THE BRIDE'S FATHER HOLDS THE SAMUEL FESSENDEN CLARKE PROFESSORSHIP OF BIOLOGY AT WILLIAMS COLLEGE AND IS A TRUSTEE OF MIDDLEBURY COLLEGE. YE EDITORS ARRIVED AT THE WILLIAMS INN ABOUT NOON IN A POURING RAIN AND LUNCHEDED WITH A DELIGHTFUL LOT OF COLE AND DEMING RELATIVES. THE STORM CEASED ABOUT THREE O'CLOCK, AND THE SUN CAME OUT.

PHYLLIS ATTENDED PINE COBBLE SCHOOL, THE NORTHFIELD SCHOOL FOR GIRLS AND WAS GRADUATED CUM LAUDE FROM MIDDLEBURY COLLEGE IN JUNE. BILLY ATTENDED NEW HAVEN HIGH SCHOOL AND THE GUNNERY, AND GRADUATED FROM MIDDLEBURY IN THE SAME CLASS AS PHYLLIS, MAJORING IN POLITICAL SCIENCE. THEIR HONEYMOON WAS SPENT MOTORING, TAKING IN CAPE ANN. FOR THE SUMMER BILLY WILL BE DIRECTOR OF THE MIDDLEBURY SUMMER PLAYGROUND WITH PHYLLIS AS ASSISTANT. THEIR ADDRESS IS CHARTER HOUSE APARTMENT, MIDDLEBURY, VT.

LIEUT. (J.G.) GEORGE (JIMMY) SARGENT GROVE, U.S.N., SON OF BARBARA SARGENT MOOREHEAD, HAS BEEN IN COMMAND OF THE MINESWEEPER USS CURLEW (AMS8) OPERATING WITH THE GROUP OF NAVAL VESSELS IN KOREAN WATERS FOR MANY MONTHS, SOMETIMES UNDER FIRE, WITH SHORT RESPIRES IN JAPAN FOR REST AND OVERHAUL TO THE SHIP. A LETTER FROM SASEBO, JAPAN, DATED MAY 27TH READS IN PART: "MY LAST LETTER, I LONG RECALL, WAS WRITTEN WHEN WE WERE JUST ABOUT TO ARRIVE IN SASEBO FOR TWO WEEKS' REST AND UPKEEP PERIOD. SINCE THEN MUCH HAS HAPPENED, AS OFTEN FOUND IN WAR, AND AFTER ABOUT FIVE DAYS OF NOT KNOWING WHAT TO EXPECT NEXT, WE WERE ORDERED OUT ONCE MORE TO THE FORWARD AREA FOR A JOB OF WORK. THE JOB TOOK TEN DAYS IN ALL AND NOW WE ARE BACK IN SASEBO ONCE MORE FOR A TEN DAY PERIOD. I HAVE SENT MY MEN TO REST CAMP AND HAVE TORN DOWN MY MAIN ENGINES; * * * WE WILL HAVE TO REMAIN FOR TEN DAYS TO BECOME READY FOR SEA. WE NEED THE REST. * * * WE LOOK FORWARD TO OUR YARD PERIOD WHEN WE EXPECT TO GET THIRTY DAYS IN THE SHIPYARD AT YOKOSUKA AND WHEN I EXPECT TO TAKE A LITTLE TIME OFF TO VISIT ONE OF THE HOTELS IN THE INTERIOR. IN THE MEANTIME WE WILL RETURN TO OUR OLD STAMPING GROUND AND DO WHAT COMES NATURALLY TO US ALL BY NOW. * * * IT IS DIFFICULT TO BELIEVE THAT I HAVE BEEN OUT HERE AS LONG AS I HAVE. THE TIME SLIPS BY WITH SO MUCH GOING ON. IT DOES NOT SEEM THAT THERE IS A JOB DONE BEFORE THERE IS ANOTHER ON THE FIRE AND WE ARE IN ON IT, IT IS OVER, THERE IS ANOTHER FEW SHORT DAYS IN SASEBO—AND THEN BACK OUT AGAIN. OF COURSE FOR MANY IT DRAGS BY HORRIBLY, THOUGH THERE IS NOT TOO MUCH OF THAT OUT HERE TO MY KNOWLEDGE. I SUPPOSE THAT NONE BUT THE TROOPS, WHO HEAVEN KNOWS WISH THEY WERE A THOUSAND MILES AWAY FROM WHERE THEY ARE, GET SO CLOSE TO THE ENEMY AS WE SWEEPS, SO FOR ME, COMBINED WITH THE SWEEPING PHASE—WHICH IS ACTIVE ENOUGH—I AM QUITE CONTENT. * * * I SEE ALSO FROM OUR OLD STANDBY, SARGENTRIVIA—A VERY WORTH WHILE AND INTERESTING PUBLICATION TO BE SURE—THAT TWO OF OUR FAMILY HAVE BIRTHDAYS COMING UP. * * * I ENCLOSE A SAMPLE OF OUR SHIP'S NEWSPAPER. * * * THE EDITOR, OUR CHIEF QUARTERMASTER, ALWAYS ADDS A BIT OF EXAGGERATED NONSENSE WHICH IS AMUSING TO US: 'THE CHO'TO DAILY COMET NEWS 22 MAY, 1951—ANOTHER SUCCESSFUL MINESWEEPING OPERATION HAS BEEN COMPLETED BY USS CURLEW AND SUPPORTING U.N. WARSHIPS. THE CURLEW BIRD NOT ONLY CLEARED THE MINE LANES BUT LAID DOWN SUCH A WITHERING FIRE ON COMMUNIST HELD CITIES THAT IT MAY HAVE CAUSED THE RETREAT OF COMMUNIST FORCES AROUND SEOUL. * * * RED OFFENSIVE THROWN INTO REVERSE, WITH DECIMATED ENEMY FORCES IN HEADLONG RETREAT ALONG VIRTUALLY THE ENTIRE FRONT'."

ON JUNE 8TH THE NAVY COMMUNIQUE MENTIONED THAT THE USS CURLEW (AMS8) WAS OPERATING WITH THE GROUP OF NAVAL VESSELS BOMBARDING WONSAN, KOREA.

NEW YORK WORLD-TELEGRAM AND SUN ON JUNE 21ST PRINTED THE FOLLOWING DESCRIPTION OF THIS "PERILOUS" WORK: "ABOARD THE MINESWEEPER REDSTART, JUNE 21.—THE SUN WAS UP WHEN I CLIMBED ABOARD THE REDSTART AND THE SHIP'S SPEAKER WAS BARKING ORDERS. 'ALL HANDS TOPSIDE', IT RASPED. YOU STAY ON DECK WHEN YOU'RE HUNTING MINES. ALL DAY. THAT WAY YOU'VE GOT A GOOD CHANCE TO SURVIVE IF YOU HIT ONE.

SAILORS BEGAN SEALING THE WATERTIGHT DOORS. SEVENTY-FIVE OF THE REDSTART'S 80-MAN CREW CROWDED ON DECK. FIVE STAYED BELOW—FOUR ENGINEERS AND A SONAR MAN. AFTER FOUR HOURS THEY'D BE RELIEVED. THE SHIP BEGAN STRINGING MINE GEAR AND MOVING SEAWARD. LATER SHE WOULD SWING BACK THROUGH THE MINE-FIELDS. LT. CMDR. T.L. CLEVER OF SAN LEANDRO, CALIF., CALLED ME ASIDE AND POINTED. 'THAT'S WHERE WE LOST THE PIRATE AND THE LEDGE,' HE SAID. 'OVER BETWEEN THAT BUOY AND THE ROCKY POINT.' THEY WERE TWO SWEEPERS. THE OTHER SWEEPS BEGAN FALLING INTO LINE. CMDR. CLEVER CALLED THE ROLL. REDSTART, DEXTROUS, CURLEW, PELICAN, HERON, WAXBILL, SWALLOW, CONDOR.

BUTCH CLEVER EXPLAINED THE OPERATION. 'WE'LL GO OUT TO SEA,' HE SAID, 'AND THEN SWEEP BACK 15 MILES.' WE GOT UNDER WAY. AT 8 A.M. THE PELICAN CUT THE FIRST MINE. IT WAS IN AN ANCHORAGE WHERE WE SPENT THE NIGHT. AT 9 O'CLOCK WE ENTERED THE MINEFIELD. AT 9:20 THE CURLEW CUT TWO MINES. THEY BOBBED INNOCENTLY TO THE SURFACE. THE HERON, NEXT IN LINE, DODGED THEM EXPERTLY. THE SWALLOW MOVED INTO POSITION AND EXPLODED THEM WITH SHELL FIRE. NOW THERE SEEMED TO BE MINES ALL OVER THE PLACE. BY 10:15 THE LINE HAD BROUGHT UP 20—EACH AS POWERFUL AS A 500-POUND BOMB. AT 1:50 WE HEADED INTO A NEW MINE LINE. AT 2:30 THE CURLEW BROUGHT UP TWO BUT A THIRD HUNG ON ITS GEAR. THE CURLEW TWISTED LIKE AN ANGRY BULL TRYING TO SHAKE IT LOOSE. THEN THE CURLEW BROKE FORMATION AND HEADED TO SEA. IT WOULD DROP HER GEAR AND THE MINE BOTH.

STILL THE REDSTART HAD NOT SCORED. THE CREW WAS EMBARRASSED. BUT AT 2:50 WE STRUCK PAY DIRT. OFF THE STARBOARD THREE BOBBED TO THE SURFACE IN RAPID SUCCESSION. THE MEN CHEERED WILDLY. SUDDENLY THE YELLING STOPPED. THE THREE MINES WERE DIRECTLY IN THE PATH OF THE DEXTROUS WHICH WAS SECOND IN LINE. HER SKIPPER COULD EITHER GO BETWEEN TWO OF THEM OR AROUND THEM. HE ELECTED TO GO BETWEEN MINES TWO AND THREE. IT WOULD BE A CLOSE SHAVE. MINE NO. 3 SUDDENLY VEERED BACK INTO THE DEXTROUS' PATH. THE SHIP TURNED SHARPLY AWAY. THERE WASN'T A SOUND ABOARD THE REDSTART. TIME STOOD STILL WHILE WE WATCHED. THE DEXTROUS ESCAPED TRAGEDY ONLY BY INCHES. LATER, THE DEXTROUS' SKIPPER SENT THE REDSTART'S SKIPPER HIS CALLING CARD WITH THREE GRAY HAIRS PASTED TO IT."

ENSIGN MICHAEL M. GROVE, USN, SON OF BARBARA SARGENT MOOREHEAD, IS STILL ON DUTY WITH THE DESTROYER, THE USS RENSHAW (DDE499), LAST REPORTED IN PEARL HARBOR, HAWAII. MIKE HOPES TO GET MORE ACTIVE DUTY SOON; BEING TIED UP FOR LONG PERIODS IS HARD ON MEN AND OFFICERS ALIKE.

BARBARA ADAMS HOLLAND, DAUGHTER OF LEICESTER B. HOLLAND, RECEIVED THE MASTER OF ARTS DEGREE IN ENGLISH ON JUNE 13TH FROM THE UNIVERSITY OF PENNSYLVANIA, WHERE SHE HAD PREVIOUSLY RECEIVED HER B.A. THE LEICESTER HOLLANDS LIVE AT 415 WEST PRICE STREET, GERMANTOWN, PHILADELPHIA 44, PA.

MARIAN R. HOLLAND, DAUGHTER OF LEICESTER B. HOLLAND, IN JUNE RECEIVED THE DEGREE OF BACHELOR OF ARCHITECTURE (B. ARCH.) FROM COLUMBIA UNIVERSITY, COMPLETING THE FOUR YEAR COURSE AFTER RECEIVING HER B.A. FROM BRYN MAWR. ABOUT HER FULBRIGHT APPOINTMENT AND OTHER PRIZES SHE WROTE ON JUNE 11TH IN RESPONSE TO YE EDITOR'S QUERY: " *** I WAS AWARDED SECOND PLACE FOR THE AMERICAN INSTITUTE OF ARCHITECTS MEDAL 'FOR THE STUDENTS WHO HAVE MAINTAINED THE BEST GENERAL STANDARD IN ALL DEPARTMENTS DURING THE ENTIRE PROFESSIONAL COURSE.' THE SECOND PLACE IS AWARDED A COPY OF 'MONT ST MICHEL AND CHARTRES' BY HENRY ADAMS. ALSO THE BORING MEDAL AWARDED TO THE WINNER OF THE BORING PRIZE COMPETITION, WHICH IS A FIVE-WEEK DESIGN PROBLEM, AND HAS ALWAYS BEEN A PROBLEM IN LANDSCAPE DESIGN SINCE I HAVE BEEN IN THE SCHOOL. ALSO THE MORTIMER HIRSH MEMORIAL PRIZE OF \$65 FOR 'THE BEST TERM PAPER SUBMITTED IN THE COURSE 'LITERATURE AND THEORIES OF ARCHITECTURE', NOW BETTER KNOWN AS THE 'LITERATURE OF ARCHITECTURAL THEORY'." HER CHIEF COMPETITOR FOR HONORS SEEMS TO HAVE BEEN HER CLASSMATE RUSSELL GIFFORD, OF LEICESTER, MASS. (OR THEREABOUTS), WHO WON THE AMERICAN INSTITUTE OF ARCHITECTS MEDAL, AND, QUOTING MARIAN, "HE TRACES HIS ANCESTORS BACK TO THE SAME GIFFARDI AS WE, SO I SUPPOSE HE IS SOME SORT OF COUSIN IF ONLY WHAT THE DOWN-EASTERS CALL A 'RELATED COUSIN'. I SHALL SAIL FOR GREECE AUGUST 8TH, IF EVERYTHING GOES AS EXPECTED. IT IS ALL VERY EXCITING AND AS YET NOT IN THE LEAST CREDIBLE. THE FULBRIGHT WILL GIVE ME A YEAR OF STUDY IN ATHENS (OR NINE MONTHS TO BE EXACT) AND THEN I HOPE TO DO SOME TRAVELLING IN EUROPE." SHE PLANS AN ARCHAEOLOGICAL CAREER, A FIELD IN WHICH BOTH HER FATHER AND MOTHER ARE DISTINGUISHED.

LUCY HOLLAND PUTNAM, DAUGHTER OF MARY (MINNIE) RUPERT HOLLAND, AND GEORGE, HER HUSBAND, WERE WEEK-END VISITORS AT THE PUBLICATION OFFICE IN JUNE DURING THE 55TH REUNION OF GEORGE'S YALE CLASS OF '96S. THE PUTNAMS HAD RECENTLY RETURNED FROM A SEVEN-WEEK TRANSCONTINENTAL MOTOR TRIP WITH HER BROTHER AND SISTER-IN-LAW, RUPERT AND MARGARET HOLLAND. THE FOUR LEFT WAYNE, PA., ON MARCH 26TH IN THE PUTNAMS CAR (REINFORCED FOR THE JOURNEY), HEADED SOUTH, GOING OVER THE SKYLINE DRIVE IN VIRGINIA WITH SNOW STILL ON THE MOUNTAINS, CROSSED A CORNER OF GEORGIA AND TENNESSEE INTO ALABAMA, WHERE FLOODS WERE ENCOUNTERED, ACROSS MISSISSIPPI TO NEW ORLEANS. THIS MONEY (IN POUNDS OR LIRE OR WHATEVER) IS GIVEN DOLLAR CREDIT IN THIS COUNTRY—I.E. SUBTRACTED FROM WHAT THEY OWE US. THESE ARE BOTH RESEARCH AND TEACHING FELLOWSHIPS. TOM HAS THE LATTER. HE CHOSE TURKEY BECAUSE THEY ARE INTERESTED IN EVERYTHING THE AMERICANS DO; APPARENTLY THEY ESPECIALLY WANT PSYCHOLOGISTS. IT SHOULD BE THRILLING TO TEACH ANYONE THAT MOTIVATED! ALSO, HE'S LIVED 9½ YEARS IN ENGLAND AND EUROPE,

AND THIS WILL BE DIFFERENT, EDUCATIONAL AND EXCITING. WE WILL COME BACK VIA NORTHERN EUROPE WHICH WILL GIVE ME A CHANCE (UNDER EXPERT GUIDANCE) TO SEE SOME MORE OF THE WORLD! I HOPE I SHALL BE ABLE TO DO SOME WORK MYSELF—HELPING IN LABS OR THE LIKE. I'M SURE I'LL FIND SOME WAY TO BE OF USE."
