STRUCK. UNDER THE FEDERAL LAW THE EMPLOYEES HAD ELECTED AS "BARGAINING AGENT" THE UNITED ELECTRICAL WORKERS UNION, WHICH HAD ON AUGUST 26TH 841 MEMBERS ON THE SARGENT PAYROLL OUT OF A TOTAL OF 1,560 FACTORY EMPLOYEES IN THE "BARGAINING UNIT". THE COMPANY AND UNION REPRESENTATIVES HAD BEEN MEETING SINCE MAY 3D TO NEGOTIATE A NEW CONTRACT TO SUCCEED THE ONE EXPIRING JULY 1ST. THE COMPANY OFFERED, SUBJECT TO APPROVAL BY THE WAGE STABILIZATION BOARD, INCREASES IN VARIOUS CATEGORIES, BEGINNING WITH A MINIMUM OF \$1 AN HOUR FOR ALL EMPLOYEES, BUILDING UP TO \$2.07 AN HOUR FOR DAY WORKERS, AND CORRESPONDING INCREASES FOR PIECE WORKERS, WITH AN ADDITIONAL PAID HOLIDAY ON GOOD FRIDAY. THIS ALL ADDED UP TO AN INCREASE OF SOME 9½ CENTS AN HOUR. THE UNION MEMBERSHIP TURNED DOWN THE RECOMMENDATION OF THEIR REPRESENTATIVES ON THE NEGOTIATING COMMITTEE AND WENT ON STRIKE FOR TWO WEEKS, FROM AUGUST 27TH TO SEPTEMBER 7TH INCLUSIVE. THEY RETURNED TO WORK AFTER BEING PROMISED (1) ONE CENT AN HOUR MORE FOR PIECE WORKERS, (2) A THIRD WEEK VACATION FOR THOSE OF 20 YEARS' SERVICE AND MORE AND (3) A REOPENING CLAUSE ON WAGES IN 6 MONTHS (INSTEAD OF AT THE END OF THE YEAR'S CONTRACT). IT WILL TAKE A LONG TIME FOR ANY OF THEM TO MAKE UP FOR THE LOSS OF TWO WEEKS' PAY AND SOME NEVER WILL MAKE IT UP. THE PLANT WAS PICKETED, BUT THERE WAS NO VIOLENCE, AND ONLY NECESSARY MAINTENANCE MEN, ETC., AND EXECUTIVES WITH A SKELETON OFFICE FORCE WORKED IN THE PLANT DURING THE STRIKE. THE COMPANY IS EMPLOYING A TOTAL OF OVER 2,000 PERSONS, AND HAS SIZABLE ORDERS FOR DEFENSE WORK AND FOR THE ARMED FORCES.

TWENTY-FOUR MORE TO HEAR FROM. 'WE EXPECT FAVORABLE REPORTS ON AT LEAST TEN OF THEM.
