

I LEFT THE CLINIC LAST FEBRUARY IN ORDER TO STUDY ALONG PEDIATRIC PSYCHIATRIC LINES. MY WORK THERE WAS TOO FULL TO ALLOW MUCH TIME FOR THAT. BUT NOW HERE IN ST. LOUIS, WHERE FACILITIES ARE EXCELLENT AND MY TIME IS MY OWN, I CAN FOLLOW ALONG ON A COURSE OF STUDY COMBINED WITH PRACTICE. I FIND MY WORK MOST INTERESTING AND STIMULATING.

"I DON'T BELIEVE I EVER MENTIONED THE FOLLOWING NOTE OF FAMILY INTEREST. AT CARLE CLINIC THERE WAS JIM KENNEDY, ONE OF THE OTHER PEDIATRICIANS, WHO BECAME ONE OF OUR BEST FRIENDS. WE DISCOVERED THROUGH HIS MOTHER THAT WE WERE THIRD COUSINS, RELATED THROUGH THE SILLIMAN FAMILY AND MY GRANDMOTHER FORBES. I BELIEVE THAT OUR GREAT GRANDMOTHERS WERE SISTERS. JANET AND I ARE PLANNING A TRIP TO TORONTO NEXT WEEK FOR THE AMERICAN ACADEMY OF PEDIATRICS MEETING, AND WE HOPE OF COURSE TO SEE SOMETHING OF THE WISER FAMILY. JIM AND BARBARA KENNEDY WILL ACCOMPANY US, SO WE EXPECT TO INTRODUCE THEM TO MORE OF THE FAMILY. WE LOVE ST. LOUIS. THERE IS SO MUCH HERE TO SEE AND DO. PEOPLE HAVE BEEN SO VERY FRIENDLY TOWARDS US. THE ZOO IS THE BEST I HAVE EVER SEEN, AND THE OUTDOOR SUMMER OPERA IS EXCELLENT. WE HOPE THAT THERE WILL BE MEMBERS OF THE FAMILY PASSING THROUGH FROM TIME TO TIME AND EXTEND TO THEM A CORDIAL INVITATION TO BE SURE TO LET US KNOW OR LOOK US UP WHEN THAT IS THE CASE. ... I SHOULD LIKE TO SAY PUBLICLY THAT I AM EXTREMELY HAPPY THAT THERE IS TO BE ANOTHER DOCTOR IN THE FAMILY. CONGRATULATIONS TO HOWARD, JR., FOR HIS CHOICE."

SARGENT & COMPANY, OF NEW HAVEN, CONN., MADE A CONTRACT ON JULY 21, 1869, WITH THE NEW HAVEN STEAMBOAT COMPANY FOR THE CARRYING OF HARDWARE FROM NEW HAVEN TO NEW YORK AND "FREIGHT" FROM NEW YORK TO NEW HAVEN ("EXCEPT THAT THE PARTY OF THE FIRST PART SHALL HAVE THE PRIVILEGE OF SENDING COAL SAND IRON AND LUMBER BY OTHER CONVEYANCES") FOR THE FIVE YEARS BEGINNING AUGUST 1, 1869. (SARGENT & CO., THE NEW YORK CO-PARTNERSHIP, CARRIED A CONSIDERABLE STOCK OF BOTH "FACTORY" AND "OUTSIDE" GOODS.) THE DOCUMENT IS ON FOUR PAGES OF LEGAL CAP PAPER IN THE HANDWRITING OF J.B. SARGENT, WHO SIGNED AS "PRESDT" FOR SARGENT & COMPANY. RICHARD PECK SIGNED AS "AGT" FOR THE NEW HAVEN STEAMBOAT COMPANY. HENRY B. SARGENT WAS THE ONLY RECORDED WITNESS—HE WAS THE ELDEST SON OF "J.B." AND HAD JUST COMPLETED HIS FIRST YEAR IN YALE'S SHEFFIELD SCIENTIFIC SCHOOL. AND OF COURSE THERE WAS AFFIXED A FIVE-CENT DOCUMENTARY REVENUE STAMP.

THE UNUSUAL FEATURE, TO QUOTE FROM THE CONTRACT, WAS "THAT THE RATE OF PAYMENT FOR TRANSPORTING ALL THE AFORESAID FREIGHT, PER TON OF 2000 LBS, SHALL BE FOR EACH MONTH DURING THE TERM OF THIS CONTRACT, ONE FOURTH PART OF THE AVERAGE PRICE PER TON OF 2240 LBS AT WHICH THE DELAWARE, LACKAWANNA AND WESTERN RAILROAD COMPANY SHALL HAVE SOLD THEIR 'STEAMBOAT' SIZE OF 'SCRANTON' COAL BY THE CARGO, DURING SAID MONTH, DELIVERABLE AT ELIZABETHPORT, N.J. AND IN CASE ELIZABETHPORT SHALL CEASE TO BE A PROMINENT PORT OF DELIVERY FOR SAID RAILROAD COMPANY'S COAL THEN THEIR PRINCIPAL PLACE OF DELIVERY NOT MORE DISTANT FROM NEW YORK SHALL BE SUBSTITUTED FOR ELIZABETHPORT IN THIS CONTRACT. AND IN CASE THE SAID RAILROAD COMPANY SHALL NOT SELL ANY OF SAID COAL SO DELIVERABLE, BY THE CARGO, DURING ANY MONTH (ONE OR MORE) THEN THE RATE OF FREIGHT AS AFORESAID SHALL BE ONE FOURTH PART OF THE CARGO PRICE AS AFORESAID OF THE COAL OF A QUALITY MOST NEARLY RESEMBLING THE SAID RAILROAD COMPANY'S COAL HAVING A PORT OF DELIVERY NOT MORE DISTANT FROM NEW YORK THAN RONDOUT. BUT FOR THE PURPOSE OF FACILITATING PROMPT PAYMENT OF FREIGHT MONEY THE SAID PARTY OF THE SECOND PART MAY COLLECT, IN THEIR USUAL MANNER, THEIR FREIGHT BILLS MADE OUT AT THEIR REGULAR CURRENT RATES; AND SOON AFTER THE END OF EACH MONTH A SETTLEMENT SHALL BE HAD BETWEEN THE PARTIES HERETO ON THE BASIS OF ONE FOURTH OF THE PRICE OF COAL AS HEREINBEFORE PROVIDED; AND IN CASE IT SHALL APPEAR THAT THE SAID PARTY OF THE SECOND PART HAS COLLECTED FOR THE MONTH MORE MONEY FOR TRANSPORTING SAID FREIGHT THAN AT THE RATE OF ONE FOURTH THE PRICE OF A TON OF COAL FOR EACH TON OF FREIGHT, AS PROVIDED, THEN THE PARTY OF THE SECOND PART SHALL PAY TO THE PARTY OF THE FIRST PART THE SURPLUS COLLECTED. AND IF IT SHALL APPEAR THAT THE PARTY OF THE SECOND PART SHALL NOT HAVE COLLECTED SUFFICIENT MONEY TO MAKE THE AMOUNT AS PER RATE HEREIN PROVIDED THEN THE PARTY OF THE FIRST PART SHALL PAY SUFFICIENT TO MAKE UP THE DEFICIENCY. ALL MONEYS TO MAKE UP SURPLUS OR DEFICIENCY AS AFORESAID SHALL BE DUE AND PAYABLE ON THE 15TH DAY OF THE MONTH IN WHICH THE SETTLEMENT IS AGREED TO BE MADE AS AFORESAID." J.B. SARGENT UNDOUBTEDLY FIGURED THAT ALL THE MONTHLY ADJUSTMENTS WOULD BE REFUNDS FROM THE STEAMBOAT COMPANY.

THE EXPIRATION DATE OF THE CONTRACT, JULY 31, 1874, SEEMS TO HAVE SLIPPED BY UNNOTICED BY EITHER PARTY. BUT PROBABLY THE TERMS OF THE AGREEMENT CONTINUED TO BE ADHERED TO, AND ON APRIL 30, 1875, IT WAS RENEWED TILL MAY 1, 1880, BY BOTH PARTIES SIGNING A RENEWAL AGREEMENT WRITTEN IN THE MARGIN OF THE ORIGINAL DOCUMENT WITH AN ADDED PROVISION THAT THE CONTRACT SHALL BE VOID ON SALE OR TRANSFER OF THE STEAMBOAT COMPANY BY THE "PRESENT OWNERS". SOME CLARIFICATION OR MODIFICATION AS RELATED TO THE PRICE OF COAL WAS MADE IN DECEMBER 1870. THIS STEMMED APPARENTLY FROM A COAL STRIKE, AS EVIDENCED BY THREE LETTERS FROM RICHARD PECK OF THE STEAMBOAT COMPANY. (THE AMOUNT OF A REFUND CHECK ENCLOSED IN ONE OF THEM WAS \$258.23.) COPY HAS BEEN PRESERVED OF ONLY ONE LETTER OF J.B.S.'S SIDE OF THE CORRESPONDENCE—AND THAT A LETTER—PRESS COPY DIFFICULT NOW TO READ, BUT THE QUESTION WAS SETTLED AMICABLY. AT ANY RATE THE ORIGINAL PRICE ARRANGEMENT WAS NOT CHANGED IN THE RENEWAL OF THE CONTRACT. MR. PECK KNEW THAT THERE WERE OTHER STEAMBOAT COMPANIES THAT WOULD LIKE THE SARGENT FREIGHT BUSINESS. IN SARGENTRIVIA OF APRIL 5, 1945, WAS DESCRIBED HOW J.B.S. BECAME THE OWNER OF A STEAMBOAT, ORIGINALLY BUILT FOR THE CITIZENS STEAMBOAT CO. AFTER THIS FREIGHT CONTRACT WAS MADE J.B.S. SOLD HIS STEAMBOAT TO THE NEW HAVEN STEAMBOAT CO.

RICHARD PECK—"COMMODORE" AS HE WAS THEN OR LATER CALLED—WAS THE BEST KNOWN OF THE MANY PECKS IN STEAMBOATING. HIS NAME WAS GIVEN TO A BOAT THAT OPERATED BETWEEN NEW YORK AND NEW HAVEN FOR 29 YEARS BEGINNING IN 1892, THEN GOING TO OTHER PARTS (OR PORTS), AND WHICH ONLY WITHIN THE LAST YEAR OR SO HAS GIVEN UP THE GHOST. THIS STEAMBOAT HAS BEEN IMMORTALIZED IN STORY AND SONG BY GENERATIONS OF YALE UNDERGRADUATES.

I HAVE BEEN WORKING AS WHAT THEY CALL A SENIOR WRITER FOR REPUBLIC AVIATION CORPORATION FOR SIX MONTHS OR SO. THAT'S IN FARMINGDALE, L.I. WE BUILD THE F-84, CALLED THE THUNDERJET, A SINGLE SEAT JET FIGHTER. I WRITE ABOUT IT FOR THE PEOPLE WHO FLY IT AND MAINTAIN IT. WORK I LIKE VERY MUCH, THOUGH IT GETS COMPLICATED. ... CROWN PUBLISHERS ARE GOING TO PUBLISH A NOVEL OF MINE CALLED 'PLEASE REMIT'. THAT MAY NOT BE THE TITLE WHEN IT COMES OUT ON NEXT SPRING'S LIST, BUT, BE SURE, I SHALL KEEP YOU ABREAST OF TITLES. ... CUT AND I ARE HERE ENSCONCED IN GREAT NECK. SHE COMMUTES VIA L.I.R.R. TO N.Y. EACH MORNING. SHE IS EXECUTIVE SECRETARY FOR A FIRM OF ARCHITECTS NAMED DAWSON, OLIVER, AND MURTAGH (THEY DO THE DOUBLEDAY BOOKSTORES, AMONG OTHER THINGS). I COMMUTE BY CAR TO FARMINGDALE. AS ACCEPTANCE OF THE APPOINTMENT REQUIRES JIM TO BE A RESIDENT OF NEW YORK CITY, THE FAMILY IS IN THE PROCESS OF MOVING FROM THE RECENTLY ACQUIRED HOUSE ON HIGH RIDGE ROAD, STAMFORD, CONN.

WILLIAM ARTHUR GOELLER, SON OF ELIZABETH (BIBBY) DEMING AND WILLIAM JOSEPH GOELLER, WAS BORN ON SUNDAY, SEPTEMBER 30TH, AT 10:44 A.M. AT THE DELAWARE HOSPITAL, WILMINGTON, DEL. MARGARET SARGENT LIE-NIELSEN, DAUGHTER OF ROBERT L. FISHER AND OF ATLEE DOWNS FISHER, WROTE FROM OXFORD, MD., ON SEPTEMBER 25TH: "... WELL, THE UNFORESEEN HAPPENED, AND INSTEAD OF GOING BACK TO STAMFORD AS PLANNED, ON THE 26TH OF AUGUST I WAS TAKEN TO THE HOSPITAL IN LONG ISLAND WITH POLIO. I HAD BEEN AT MONTAUK POINT FOR THE WEEK-END WITH LEE JUST PRIOR TO THE END OF THE CHARTER.
