THOMAS O. SARGENT, SON OF THOMAS D. SARGENT, AND A STUDENT IN THE BERKELEY DIVINITY SCHOOL, APPEARED ANONYMOUSLY IN A SERIES OF PICTURES IN A POSTER HEADED "WHERE DO YOU GET YOUR RECTOR? THE STEPS WHICH A MAN MUST TAKE WHO DESIRES TO ENTER THE EPISCOPAL MINISTRY." THE POSTER WAS PUBLISHED EARLY IN THE YEAR BY THE ALUMNI COMMITTEE OF BERKELEY DIVINITY SCHOOL, NEW HAVEN, CONN., IN CONNECTION WITH THEOLOGICAL EDUCATION SUNDAY.

SARGENT & COMPANY HAS ESTABLISHED A FOUR-YEAR UNDERGRADUATE SCHOLARSHIP AT YALE FOR WHICH AN EMPLOYEE OF THE COMPANY OF A YEAR'S STANDING OR A CLOSE RELATIVE OF AN EMPLOYEE IS ELIGIBLE. THE SCHOLARSHIP IS NAMED FOR HENRY BRADFORD SARGENT (1851-1927), WHO WAS PRESIDENT OF THE COMPANY FROM 1917 TO 1927 AND WAS A TRUSTEE (MEMBER OF THE CORPORATION) OF YALE FROM 1902 TO 1920. THE FIRST AWARD WILL BE TO A YOUNG MAN IN THE FALL OF 1953, THE SELECTION TO BE MADE FROM ELIGIBLE APPLICANTS BY YALE'S SCHOLARSHIP COMMITTEE. THE RECIPIENT OF THE SCHOLARSHIP WILL RECEIVE UP TO A MAXIMUM OF \$1,600 A YEAR. UNDER CERTAIN CONDITIONS THIS AMOUNT MAY BE DIVIDED AMONG TWO OR MORE. THE OBJECTS OF THE COMPANY'S GIFT WERE FIRST TO HELP EMPLOYEES OR THEIR SONS (EXCLUSIVE OF OFFICERS AND DIRECTORS) TO OBTAIN A COLLEGE EDUCATION AND SECOND TO MAKE A FINANCIAL CONTRIBUTION TO YALE WHICH HAS BEEN CELEBRATING ITS 250TH ANNIVERSARY. WHILE IT IS HOPED THAT THE RECIPIENT OF THE SCHOLARSHIP WILL AFTER GRADUATION WORK FOR THE COMPANY, THERE IS NO REQUIREMENT THAT HE DO SO. A JOINT ANNOUNCEMENT OF THE SCHOLARSHIP BY PRESIDENT A. WHITNEY GRISWOLD OF YALE AND PRESIDENT C. FORBES SARGENT OF THE COMPANY WAS MADE IN THE NEW HAVEN REGISTER ON SUNDAY, OCTOBER 5TH, FOLLOWING THE DISTRIBUTION OF A DESCRIPTIVE BOOKLET TO COMPANY EMPLOYEES ON OCTOBER 3D. THE SUGGESTION FOR A SCHOLARSHIP WAS FIRST MADE BY W. SARGENT LEWIS, VICE PRESIDENT AND SECRETARY OF THE COMPANY, WHO WAS A MEMBER OF THE COMMITTEE TO OBTAIN GIFTS IN HONOR OF YALE'S ANNIVERSARY.

JOSEPH BRADFORD SARGENT (1822-1907), PRESIDENT OF SARGENT & COMPANY, WROTE THE FOLLOWING LETTER (SPELLING UNCORRECTED) FROM NEW HAVEN ON APRIL 19, 1865, TO HIS SISTER, LUCY SARGENT RUPERT (1824-1895), IN LOUISVILLE, KY., DESCRIBING HIS HANDLING OF A LABOR PROBLEM AT THE FACTORY. THE NEWS-PAPER CLIPPINGS HAVE BEEN LOST, BUT YE EDITOR FOUND THE ARTICLES IN THE FILES AT THE YALE LIBRARY. THE FIRST ONE APPEARED IN THE DAILY REGISTER OF TUESDAY, APRIL 11, 1865, UNDER THE CAPTION "MEETING OF WORKINGMEN." THE SECOND APPEARING ON MONDAY, APRIL 17, BEGAN WITH A SORT OF EDITORIAL APOLOGY AND QUOTED J.B. SARGENT'S REPLY IN WHICH HE LISTED FOUR "FALSE STATEMENTS" IN THE APRIL 11 ARTICLE. ALL OF THIS HAPPENED JUST AT THE CLOSE OF THE CIVIL WAR.

"DEAR LUCY:

"I INCLOSE TWO ARTICLES CUT OUT OF THE 'NEW HAVEN REGISTER', THE MEANEST, LOWEST, COPPERHEAD NEWSPAPER IN NEW ENGLAND EXCEPT THE 'HARTFORD TIMES' WHICH IS JUST EVEN WITH IT.

"AS MY NAME APPEARED, AMONG OTHERS, AS VICE PRESIDENT OF TWO OR THREE OF THE LINCOLN MEETINGS LAST FALL, THE EDITORS WERE VERY GLAD TO GET AN OPPORTUNITY TO HOLD OUR CONCERN UP TO THE UN-TERRIFIED RABBLE AND WORKINGMEN AS A TYRANICAL INSTITUTION, EVER READY TO TRAMPLE UPON THE RIGHTS OF THE LABORING CLASSES.

"I REDUCED WAGES 10 PER CENT MARCH 23, AND OUR MEN MADE NO OBJECTION WHATEVER. THE WAGES OF THE MOLDERS IN IRON FOUNDRY, ONLY, WERE REDUCED, THEY HAVING BEEN RAISED TO A HIGHER PROPORTIONATE FIGURE THAN ANY OTHER CLASS. THEIR WAGES ARE ALWAYS THE FIRST TO GO UP & FIRST TO GO DOWN. WELL, AS I SAID, THEY MADE NO OBJECTION. BUT WORKMEN IN OTHER FOUNDRIES AND THE COMMON LABORERS OF THE CITY SAW DANGER OF A GENERAL REDUCTION, IF OUR MEN SUBMITTED.

"SO, ALL BEING CATHOLIC IRISH, A MOVEMENT WAS STARTED TO BRING OUTSIDE PRESSURE ON OUR MEN TO STRIKE—A FUND BEING RAISED TO PAY EACH ONE OF OUR MEN WHO STRUCK THE SUM OF SEVEN DOLLARS PER WEEK SO LONG AS THE STRIKE SHOULD LAST. TWO OF OUR MEN LEFT BEFORE THE STRIKE TO AVOID BEING IN IT. OTHERS RESISTED THE MOVEMENT SO LONG AS THEY COULD BY VOICE & VOTE & FINALLY OUTSIDE PRESSURE & THREATS BROUGHT ALL TO THE SCRATCH. WE HAVE 12 APPRENTICES WHOSE WAGES WERE NOT AFFECTED BY THE REDUCTION. THEY REMAINED, BUT COULD NOT VERY WELL WORK WITHOUT A FEW OLD HANDS (JOURNEYMEN) TO HELP OUT.

"A WEEK AGO LAST MONDAY A COMMITTEE CAME IN TO THE OFFICE AND ASKED A RESTORATION OF OLD WAGES, WHICH WAS DECLINED. THEY THEN INFORMED ME THAT THERE WOULD BE NO MORE WORK IN THE FOUNDRY AFTER THAT DAY UNTIL THEIR REQUEST WAS GRANTED. ANTICIPATING MY REPLY, A BIG WORKINGMEN'S INDIGNATION MEETING HAD BEEN ARRANGED FOR, AND SPEAKERS FROM 'FOREIGN PARTS' HAD BEEN INVITED & SOME WERE PRESENT.

"SO TO TAKE THE WIND ALL OUT OF THEIR SAILS I SENT A NOTE TO FOREMAN INFORMING HIM THAT I WISHED HIM TO STATE TO THE MOLDERS, THAT, UNDER THE CIRCUMSTANCES, AND AFTER MORE REFLECTION, I HAD CONCLUDED TO COMPLY WITH THEIR REQUEST & COMMENCE NEXT DAY WITH OLD WAGES. SO THE SPEECHES THAT WERE TO HAVE BEEN DELIVERED WERE ALL LOST. NO INDIGNATION WAS TO BE RAISED.

"BUT THIS COPPERHEAD PAPER COULD NOT LET THE THING PASS WITHOUT REPORTING THE ABSURD STORIES THAT HAD BEEN INVENTED FOR THE OCCASION.

"THE MEETING WAS MONDAY NIGHT—THE VERY DAY THAT I CONSENTED TO RESTORE WAGES—TO COMMENCE WITH TUESDAY. TUESDAY MORNING I TOOK FIRST TRAIN TO NEW YORK, AFTER LEAVING INSTRUCTION WHAT TO DO, AND ABOUT NOON I TELEGRAPHED FROM N.Y. 'BUSINESS VERY DULL. DISCHARGE TWENTY MOLDERS'—WHICH WAS DONE TUESDAY NIGHT. WEDNESDAY I TELEGRAPHED 'BUSINESS DULLER. DISCHARGE TWELVE OR FIFTEEN MOLDERS' AND CAME HOME. THEY WERE DISCHARGED. THE FOLLOWING SATURDAY WE DISCHARGED ALL BUT FIVE OR SIX AND THE APPRENTICES. A HEAVY OUTSIDE PRESSURE WAS BROUGHT TO BEAR UPON THOSE NOT DISCHARGED TO PREVENT THEIR WORKING. THEY WERE OUR BEST MEN AND THEY HAD OPPOSED THE STRIKE ALL THEY COULD. THREATS WERE MADE & MEETINGS WERE HELD TO PREVENT THEM FROM WORKING. BUT THEY SAID THEY SHOULD WORK AND ABIDE THE CONSEQUENCES. THEY ARE AT WORK WITH THE TACIT CONSENT OF ALL.

"OUT OF 22 MOLDERS EMPLOYED IN A NEIGHBORING MALLEABLE IRON FOUNDRY 14 WERE EMPLOYED ON WORK FOR US. WHILE I WAS IN NEW YORK I TELEGRAPHED 'WITHDRAW ALL PATTERNS FOR MALLEABLE IRON' AND 14 MOLDERS WERE CONSEQUENTLY DISCHARGED FROM THAT FOUNDRY. THE OTHER FOUNDRIES ARE ALL IDLE OR WORKING ONLY OCCASIONALLY AND WITH VERY LIGHT FORCE. OUR FORCE IS ORDINARILY ABOUT EQUAL TO THAT OF ALL THE OTHER FOUNDRIES IN THE CITY.

"OUR MEN ARE EXCEEDINGLY ANXIOUS TO SURRENDER AND HAVE SENT SEVERAL COMMITTEES TO 'ARRANGE'. I TELL THEM THAT I HAVE ALWAYS RECOGNISED, AND LIVED UP TO, A CERTAIN MORAL OBLIGATION THAT AN EMPLOYER IS UNDER—THAT OF KEEPING ALL HANDS EMPLOYED IN DULL TIMES SO LONG AS HE CAN FURNISH MONEY TO PAY THEM AND WITHOUT PROSPECT OF LOSS ON THE GOODS MANUFACTURED. BUT THAT THE ACTION OF THE MEN HAS RELEIVED ME FROM THAT, AND I WILL GO TO WORK WHENEVER WAGES GET DOWN TO SATISFACTORY PRICES AND BUSINESS STARTS UP.

"RAISING THEIR WAGES,—SUBMITTING SO PROMPTLY TO THE STRIKE—AND THEN DISCHARGING THEM NEXT DAY,—IS WHAT THEY CANNOT SEE THROUGH. BUT I TELL THEM THAT A STRIKE IS A STATE OF WAR AND THAT I COULD NOT BEAR THE IDEA OF THEIR LEAVING ME IN A STATE OF WAR. SO TO MAKE PEACE I SURRENDERED.

"AS I YIELDED TO THE STRIKE THEY DONOT GET THE SEVEN DOLLARS PER WEEK.

"WE ARE GLAD TO BE RID OF THEM FOR A WHILE, AND WE CAN GET ALL WE WANT ANY DAY AT OUR OWN PRICE. THEY WILL LIVE AND LEARN.

"THE CHURCHES ARE ALL OPEN NOW FOR FUNERAL SERVICES OF PRESIDENT LINCOLN. AS ALL THE PREACHERS WILL TAKE THE GROUND THAT HIS MURDER WAS THE WORK OF PROVIDENCE (GOD) I DONOT ATTEND, FOR I BELIEVE HIS MURDER WAS THE WORK OF INFERNAL SCOUNDRELS—AND THAT GOD HAD NO HAND IN IT.

JOSEPH DENNY SARGENT (1787-1849), GREAT GRANDFATHER OF YE EDITOR'S GENERATION, A MANUFACTURER OF HAND AND MACHINE CARDS IN LEICESTER, MASS., RECEIVED THE FOLLOWING LETTER FROM A MAKER OF BOXES, PRESUMABLY OF WOOD. YE EDITOR BELIEVES THAT "TWO DOZ BOXES" MEAN BOXES TO HOLD TWO DOZEN PAIRS OF HAND CARDS. THE WRITER OF THE LETTER IS NOT MUCH OF A SPELLER. HIS PESSIMISM MAY HAVE BEEN CAUSED BY THE WIDELY HELD BELIEF THAT THE MILLENIUM WAS NEAR, WILLIAM MILLER, THE EVANGELIST, HAVING CALCULATED THAT THE WORLD WOULD COME TO AN END ABOUT 1843.

"ATHOL APRIL 15TH 1845

"MR SARGENT, I SEND YOU 113 TWO DOZ BOXES & 101 ONE DOZ & IF YOU ARE IN WANT OF MORE BOXES OF ME PLEASE TO SEND THE DEMANTIONS & IF WE REMAIN HERE ON THE EARTH IN ITS PRESENT CONDITION I WILL MAKE THEM FOR YOU

"EBENEZER STRATTON"

JAMES TROWBRIDGE (1636-1717), ANCESTOR OF MOST OF US, A SKETCH OF WHOM AND OF HIS FATHER, THOMAS, APPEARED IN SARGENTRIVIA OF JUNE 12, 1945 (SEE ALSO GENEALOGICAL CHART IN SARGENTRIVIA OF JULY 16, 1946) HAD A NEPHEW, WILLIAM TROWBRIDGE, WHOSE HOME WAS IN NEW HAVEN WHO WAS A SEA CAPTAIN.

IN THAT REMARKABLE BOOK BY COTTON MATHER, MAGNALIA CHRISTI AMERICANA, OR THE ECCLESIASTICAL HISTORY OF NEW-ENGLAND, FROM THE FIRST PLANTING IN THE YEAR 1620, UNTO THE YEAR OF OUR LORD, 1698, PUBLISHED FIRST IN LONDON IN 1702, IN BOOK VI, P. 9, IS RECORDED THE FOLLOWING:

"MANTISSA

"OVER AND ABOVE THE NUMBER OF SEA DELIVERANCES INTENDED FOR THIS CHAPTER, WE WILL ADD ONE MORE, WHICH IS A LATE AND A FRESH INSTANCE, AND ATTESTED BEYOND ALL CONTRADICTION.

"ON THE 16TH OF OCTOBER, IN THIS PRESENT YEAR 1697, THERE ARRIV'D AT NEW HAVEN A SLOOP OF ABOUT 50 TUNS, WHEREOF MR. WILLIAM TROWBRIDGE WAS MASTER: THE VESSEL BELONG'D UNTO NEW-HAVEN, THE PERSONS ON BOARD WERE SEVEN; AND 17 LONG WEEKS HAD THEY NOW SPENT, SINCE THEY CAME FROM THEIR PORT, WHICH WAS FAYAL. BY SO UNUSUALLY TEDIOUS A PASSAGE A TERRIBLE FAMINE UNAVOIDABLY CAME UPON THEM; AND FOR THE FIVE LAST WEEKS OF THEIR VOYAGE THEY WERE SO DESTITUTE OF ALL FOOD, THAT THRO' FAINTNESS THEY WOULD HAVE CHOSEN DEATH RATHER THAN LIFE. BUT THEY WERE A PRAYING AND A PIOUS COMPANY: AND WHEN THESE POOR MEN CRY'D UNTO THE LORD, HE HEARD AND SAV'D THEM. GOD SENT HIS DOLPHINS TO ATTEND 'EM; AND OF THESE THEY CAUGHT STILL ONE EVERY DAY, WHICH WAS ENOUGH TO SERVE 'EM; ONLY ON SATURDAYS THEY STILL CATCH'D A COUPLE; AND ON THE LORD'S DAYS THEY COULD CATCH NONE AT ALL. WITH ALL POSSIBLE SKILL AND CARE THEY COULD NOT SUPPLY THEMSELVES WITH THE FISH IN ANY OTHER NUMBER OR ORDER; AND INDEED WITH AN HOLY BLUSH AT LAST THEY LEFT OFF TRYING TO DO ANY THING ON THE LORD'S DAYS, WHEN THEY WERE SO WELL SUPPLY'D ON THE SATURDAYS. THUS THE LORD KEPT FEEDING A COMPANY THAT PUT THEIR TRUST IN HIM, AS HE DID HIS ISRAEL WITH HIS MANNA: AND THIS THEY CONTINU'D UNTIL THE DOLPHINS CAME TO THAT CHANGE OF WATER, WHERE THEY US'D TO LEAVE THE VESSELS. THEN THEY SO STRANGELY SURRENDERED THEMSELVES, THAT THE COMPANY TOOK TWENTY SEVEN OF 'EM; WHICH NOT ONLY SUFFIC'D THEM UNTIL THEY CAME ASHORE, BUT ALSO SOME OF 'EM WERE BROUGHT ASHORE DRY'D, AS A MONUMENT OF THE DIVINE BENIGNITY."
