THERE IS AMPLE ROOM FOR GINGER TO RUN IN, AND WE CAN HAVE HERE, SO WE ARE REALLY THRILLED TO HAVE FOUND THIS PLACE. JOHAN (HER STEPSON) WILL SPEND HIS SUMMER VACATION WITH US AGAIN, AND IS DUE THE FIRST WEEK IN JUNE. HE IS BRINGING A FRIEND WITH HIM FROM SCHOOL, WHICH WILL BE NICE, AND BOTH BOYS WILL HAVE-JOBS ON POWERBOATS. . . . "

OUR COMPANY WAS SO FASCINATING AND THE SNOW-TOPPED MOUNTAINS SO LOVELY THAT WE WERE NOT AT ALL BORED.

(WE HAVE OMITTED MARIAN'S VERY BRIEF ACCOUNT OF HER EXPERIENCES AT BEIRUT, AT BA'ALBEK AND
THE GRAC DES CHEVALIERS, "ONE OF THE FINEST AND BEST PRESERVED OF THE CRUSADER CASTLES", AND AT CYPRUS.
THESE EXPERIENCES SHE DESCRIBED MORE FULLY IN A LETTER TO HER MOTHER OF JANUARY \$4, WHICH IS QUOTED
BELOW.)

"THAT NIGHT SEYRIG WAS GIVING HIS ANNUAL NEW YEAR'S DINNER FOR THE INSTITUTE AND HAD INVITED US RIGHT OFF THE BAT. AS A MATTER OF FACT WHILE WE WERE SITTING IN OUR ROOM WAITING FOR EIGHT O'CLOCK TO ROLL AROUND, A SERVANT SUMMONED US, AND WE MEEKLY TROTTED UPSTAIRS, SUPPOSING WE WERE LATE. INSTEAD, WE FOUND WE WERE ALMOST THE FIRST AND WERE ABLE TO MEET THE OTHERS AS THEY CAME IN, INSTEAD OF BEING THRUST INTO THE MIDDLE. IT WAS AN EXCELLENT BUFFET DINNER WITH GOOD WINE AND OTHER DRINKS BEFORE AND

APTER. ROSEMARY UNDERSTANDS VERY LITTLE FRENCH, BUT ALL THOSE WHO COULD SPEAK ANY ENGLISH AT ALL WENT OUT OF THEIR WAY TO BE NICE TO US, AND BOTH THE SEYRIGS WERE EXTREMELY CORDIAL. THERE WAS AN AMUSING YOUNG MAN THERE NAMED FREJOULE OR FREJUS WHO HAD BEEN AT COSA AND WHO KNEW MISS MARTI.

"THIRDLY, SEYRIG HAD ASKED WHETHER WE WANTED TO GO TO THE CRAC. WE TOLD HIM OUR TROUBLES, BUT HE POOH-POOHED THEM, INCLUDING THE QUESTION OF GETTING BACK INTO SYRIA, AND SAID THEY WOULD GET A DRIVER WHO WOULD GUARANTEE TO GET US THERE OR OTHERWISE NOT BE PAID. NOW THAT WE DID NOT HAVE TO PAY FOR A HOTEL ROOM, WE THOUGHT WE MIGHT MANAGE, AND WHEN WE LEARNED THAT IT WOULD BE ONLY ABOUT \$24 AND THAT ONE OF THE FRENCH STUDENTS WANTED TO GO TOO, WE AGREED EAGERLY AND THE SECRETARY UNDERTOOK TO FIND THE DRIVER WHO HAD TO HAVE A SYRIAN LICENSE. THE NIGHT BEFORE WE LEARNED THAT, OWING TO IN-SUFFICIENT STAMPS IN OUR PASSPORTS, THE SYRIANS MIGHT REFUSE TO RENEW OUR VISAS FOR A DAY AS HAD BEEN EXPECTED, WHICH WOULD COST US \$5 APIECE, BUT WE WERE STILL DETERMINED TO GO. THE DAY DAWNED WINDY AND THREATENING, OUR FIRST HINT OF BAD WEATHER, BUT WE STARTED ABOUT 8: 15 ACCOMPANIED BY A M. GUARDIN. WHO SPOKE EXCELLENT ENGLISH. WE DROVE ALONG THE COAST TO TRIPOLI, THROUGH SMALL VILLAGES-ONE OF TENTS-

AND BANANA PLANTATIONS. JUST BEYOND TRIPOLI, WHICH HAS A GREAT MANY FACTORY CHIMNEYS, WE TURNED IN-LAND ON THE ROAD TO HOMS, AND AS THE ROAD GREW WORSE SOON REACHED THE BORDER. AT THAT PLACE THE MOUNTAINS CLOSE IN AND THE WIND WHIPPING OVER THE BARE PLAINS FROM THE SEA IS VERY STRONG, APPARENTLY AT ALL TIMES. IT WAS ALL GUARDIN COULD DO TO HOLD THE CAR DOOR OPEN SO THAT HE COULD GET IN AGAIN AFTER VISITING THE POLICE." (TO BE CONTINUED)

## WEDDING ANNIVERSARIES

MAY 23 - (17TH) CATHERINE COLE AND ROBERT PERCY TATE (2D) MARGARET SARGENT FISHER AND DISTEIN LIE-NIELSEN

THE COLONY OF NEW YORK IN A LAW PASSED NOVEMBER 10, 1702, OFFERED THE FOLLOWING BOUNTIES FOR THE KILLING OF A WOLF IN THE VARIOUS COUNTIES: IN SUFFOLK, QUEENS AND KINGS 43; IN WESTCHESTER 20s IF KILLED BY A CHRISTIAN, 10s. IF KILLED BY AN INDIAN; IN ALBANY 10s.; AND IN RICHMOND 30s. IF KILLED BY A CHRISTIAN, 158. IF KILLED BY AN INDIAN. HALF THOSE AMOUNTS WERE TO BE PAID FOR KILLING A WOLF WHELP. ON SEPTEMBER 18, 1708, "FOR THE MORE EFFECTUAL PRESERVATION OF DEER, AND OTHER GAME" THE FOLLOWING WAS PASSED:

"That from and after the Publication Hereof, whatsoever Person or Persons, Freeman or Slave, Christian or Indian, shall destroy, or kill any Wolf or Wolves, or their Whelp or Whelps, and Wild-Cat OR WILD-CATS, THEIR CATLING OR CATLINGS, ANY FOX OR FOXES, THEIR PUPPY OR PUPPIES, AND SQUIRRELS, CROWS, AND BLACK-BIRDS, OR THEIR YOUNG-ONES, IN THE COUNTIES OF SUFFOLK, QUEENS COUNTY, AND KINGS COUNTY; SHALL HAVE AND RECEIVE, AS A REWARD FOR EACH WOLF SO DESTROYED AND KILLED, THE SUM OF FIVE Pounds, current Money of this Colony; and for every such Whelp, under a Year old, so destroyed and KILLED, THE SUM OF FIFTY SHILLINGS, CURRENT MONEY AFORESAID; AND FOR EACH WILD-CAT AND FOX, THE SUM OF THREE SHILLINGS; AND FOR EACH THEIR CATLINGS, PUPPIES, OR CUBS, EIGHTEEN PENCE; AND FOR EACH SQUIRREL, THREE PENCE; AND FOR EACH CROW, THREE PENCE; AND FOR EVERY THEIR YOUNG-ONES, TWO PENCE; AND FOR BLACK BIRDS, AFTER THE RATE OF FOUR PENCE HALF-PENNY THE DOZEN; AND THEIR YOUNG-ONES THREE PENCE THE DOZEN; AND THAT IN THE COUNTY OF RICHMOND, FOR KILLING WILD-CATS, FOXES, CROWS, AND BLACK-BIRDS, AND THEIR YOUNG-ONES, THE LIKE PRICE AND REWARD ABOVE-MENTIONED."

JEHU ROBINSON WAS THE FATHER OF CHLOE CAROLINE ROBINSON COLLIER (1782-1864), GREAT-GREAT-GRANDMOTHER OF YE EDITOR'S GENERATION, AS SHOWN IN THE GENEALOGICAL CHART IN SARGENTRIVIA OF MARCH 20, 1951, THE DATES OF HIS BIRTH AND DEATH ARE NOT KNOWN, BUT WE KNOW THAT HIS CHILDREN BECAME ORPHANS WHEN QUITE YOUNG. HE WAS MARRIED IN EAST HAVEN, CONN., IN 1769 TO ELIZABETH AUGUR (1749-1783), ACCORDING TO DODD'S "EAST HAVEN REGISTER" AND JACOBUS' "FAMILIE'S OF ANCIENT NEW HAVEN". THEIR SEVEN CHILDREN WERE BAPTIZED IN CENTER CHURCH, NEW HAVEN. IN RECORDING THE SUDDEN DEATH IN 1782 OF ONE OF THE CHILDREN JEHU IS CALLED "CAPT." IN THE CHURCH RECORDS. HIS NAME DOES NOT APPEAR IN "CONNECTICUT MEN IN THE WAR OF THE REVOLUTION, WAR OF 1812 AND WAR WITH MEXICO", PUBLISHED BY THE STATE IN 1889. IN THE CONNECTICUT JOURNAL AND THE NEW HAVEN POST-BOY, THE NEW HAVEN WEEKLY NEWSPAPER, HIS NAME APPEARS IN 1773, 1774, AND 1775 UNDER THE COLUMN "CUSTOM HOUSE, NEW HAVEN", "ENTERED IN", AND "CLEARED OUT" AS MASTER (CAPTAIN) FIRST OF THE SLOOP "ELIZABETH" AND THEN OF THE SLOOP "DOLPHIN". IN EVERY ONE OF THE ENTRIES THE VESSEL HAD COME FROM OR WAS BOUND FOR NEW YORK. THE EARLIEST ENTRY FOUND SHOWED THE "ELIZABETH" HAD CLEARED OUT FOR NEW YORK ON DECEMBER 31, 1772. THE LAST ENTRY OF THE "ELIZABETH" WAS WHEN IT CLEARED OUT FOR NEW YORK ON JULY 22, 1773. THE SLOOP "DOLPHIN" FIRST NOTED IN THE RECORD UNDER JEHU ROBINSON'S COMMAND WAS WHEN IT WAS ENTERED IN FROM NEW YORK ON JULY 29, 1773. IN THE NEWSPAPER OF NOVEMBER 5, 1773, THE "DOLPHIN" IS ENTERED IN ON NOVEMBER 4, AND IN THAT ISSUE IS ALSO THE FOLLOW-ING ADVERTISEMENT (REPEATED IN SOME SUBSEQUENT ISSUES): "TO BE SOLD ON VERY REASONABLE TERMS, THE SLOOP DOLPHIN, LYING IN NEW-HAVEN HARBOUR, 16 OR 18 TONS BU[R]THEN, WITH ALL HER TACKLE AND APPAREL. FOR TERMS APPLY TO ABRAHAM AUGUR." THE LATTER WAS JEHU ROBINSON'S FATHER-IN-LAW AND WAS CALLED AN INN HOLDER IN THE "AUGUR GENEALOGY". THE ADVERTISEMENT WAS REPREATED IN SUBSEQUENT ISSUES OF THE NEWS-PAPER, BUT PROBABLY NO SALE TOOK PLACE, FOR THE "DOLPHIN" WITH JEHU AS MASTER APPEARED LATER IN THE CUSTOM HOUSE ENTRIES SEVERAL TIMES, ALWAYS BOUND FOR OR COMING FROM NEW YORK, BETWEEN SEPTEMBER 30, 1774, AND APRIL 5, 1775. IN THE LATTER MONTH THE REVOLUTIONARY WAR BROKE OUT, AND NEWSPAPER REPORTS OF CUSTOM HOUSE ENTRIES CEASED. ONE FURTHER BIT OF INFORMATION ABOUT JEHU ROBINSON: THE FOLLOWING ADVERTISEMENT APPEARED IN THREE ISSUES OF THE JOURNAL-FOR JULY 1, 8, AND 22, 1774:

"TO BE SOLD, THE DWELLINGHOUSE OF THE SUBSCRIBER, SITUATED NEAR THE
WATER SIDE IN NEW-HAVEN, WITH 24 RODS
OF LAND-FOR CONDITIONS OF SALE, APPLY
TO JEHU ROBINSON."
