"KEYWAYS", THE SARGENT & COMPANY EMPLOYEES! MAGAZINE, IN ITS JUNE ISSUE, SHOWS PHOTOGRAPHS OF THE TEN MEN AND ONE WOMAN STILL ACTIVE IN THE COMPANY'S EMPLOY WHO HAVE SERVICE RECORDS OF FIFTY YEARS OR OVER. THE DEAN OF THE GROUP IS ROBERT SHELTON WHO BEGAN HIS EMPLOYMENT IN THE NEW YORK SALES OFFICE IN NOVEMBER 1879, NEARLY 74 YEARS AGO, TRANSFERRING TO NEW HAVEN IN 1912. THIS LONG SERVICE RECORD WAS PARTICULARLY INTERESTING TO THE EDITOR OF "THE LOCKSMITH LEDGER", A TECHNICAL MAGAZINE OF THE LOCK INDUSTRY, AND FEATURED IT IN A RECENT ISSUE.

JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR'S GENERATION, WROTE THE FOLLOWING LETTER TO HIS FIANCEE WHO BECAME HIS SECOND WIFE APRIL 22, 1878. "OUR WORCESTER FACTORY" WAS THE PLANT OF THE SARGENT CARD CLOTHING CO. MRS. SWAN WAS ONE OF FLORENCE'S SISTERS.

"WORCESTER, FEBY. 11, 1878.

MY DEAR FLORENCE:

I HAVE BEEN SNOW AND STORMBOUND AT MY BROTHER'S IN LEICESTER, SIX MILES FROM HERE UNTIL THIS MORNING. THE STORM WAS UNCEASING, ALMOST, TILL THIS MORNING AND AS I TOOK COLD ON OR ABOUT THE TIME I TRAVELLED WITH MY DARLING A FEW DAYS AGO, I KEPT HOUSED UP AND ON HALF RATIONS. I BLESS YOU AND YOUR SISTERS FOR MAKING ME TO UNDERSTAND THE VIRTUES OF BEEF TEA, AND FOR TWO OR THREE DAYS I KEPT IT READY FOR USE AND DRANK IT 'LITTLE AND OFTEM'. I ALSO ATE A FEW OF THOSE LITTLE PELLETS THAT 'DO NO HARM' AND FOUR TIMES EACH DAY TOOK A LITTLE WHITE POWDER (CHALK, PERHAPS) ABOUT THE SIZE OF A LADY'S 'PINCH OF SNUFF'. THIS MORNING FOUND ME AS WELL AS EVER IN RESPONSE TO A BEAUTIFUL DAY, AND WITH MY BROTHER GEORGE, WHO ARRIVED FROM NEW YORK SUNDAY MORNING, I CAME TO OUR WORCESTER FACTORY.

EXPECT TO SEE ONE OR BOTH OF OUR SISTERS IN BOSTON THIS EVENING. MRS. SWAN, MOST CERTAINLY, BECAUSE I KNOW ABOUT WHERE SHE RESIDES AND INTEND TO STOP AT THE SAINT JAMES HOTEL WHICH IS SOMEWHERE NEAR (NOT A THOUSAND MILES AWAY) HER HOME. I HOPE TO SEE THE DARLINGEST BEING (FOR ME) THAT WALKS THE EARTH TOMORROW EVENING. 

I WISH I COULD SAY THAT MY BROTHER EDWARD IS BETTER, BUT I FEAR THAT I CANNOT. EVERY OTHER DAY - HE HAS A CHILL COME OVER HIM - IN THE EVENING - WHICH EXHAUSTS HIS STRENGTH, AND IN WHICH HE FEELS SURE HE WILL DIE AND SO EXPRESSES HIMSELF AS CALMLY AS THOUGH HE WAS SPEAKING OF ANY ORDINARY EVENT SURE TO IMMEDIATELY TAKE PLACE. IT IS IN VAIN THAT WE TELL HIM THAT HE IS NO WORSE THAN WHEN HE HAD THE PREVIOUS ATTACKS. HE FEELS SURE OF SINKING RAPIDLY, AND AT BREAKFAST THE NEXT MORNING HIS APPETITE IS EQUAL TO A GOOD BEEFSTEAN MEAL. HIS DR. SAYS HE NEVER SAW NOR READ OF SUCH A CASE. MY COUSIN, DR. SARGENT OF WORCESTER IS GOING UP THIS AFTERNOON ON CONSULTATION. MY BROTHER GEORGE WILL BE THERE BUT I CANNOT AS IT IS NECESSARY THAT I GO TO BOSTON AND HOME. I AM SORRY TO WRITE YOU UPON 80 SAD A SUBJECT, BUT YOU ARE A PART OF ME AND I CANNOT HELP PUTTING A PART OF MY SORROW ON YOU AND THEN IT WILL VANISH.

YOU ARE SUCH A GOOD, LOVING, TRUSTING SOUL THAT NOTHING CAN WEARY YOU. BUT AS I MUST FINISH THIS LETTER AND TAKE THE 5 O'CLOCK TRAIN TO BOSTON I MUST LEAVE SAD MATTERS AND TELL YOU ONLY THAT I WANT TO HAVE YOU WITH ME MORE AND MORE AND I DONOT LIKE THIS TRAVELLING ALONE. I WANT YOU ON THE SAME SEAT IN THE CARS, AT MY SIDE AT THE HOTEL TABLE AND ON MY ARM IN THE STREET. BUT I MUST WAIT THE SLOW BUT SURE MARCH OF THE WEEKS.

DONOT FORGET ME BEFORE TOMORROWNIGHT AND THEN ! WILL TRY TO REFRESH YOUR MEMORY ALTHOUGH ! SHALL BE TIRED I FEAR. I HAVE MUCH TO DO BEFORE THEN.

IN THE CODE OF LAWS, ESTABLISHED IN MAY 1650 BY THE GENERAL COURT (1.E. THE LEGISLATURE) OF CONNECTICUT COLONY, PRINTED IN 1850 IN "THE PUBLIC RECORDS OF THE COLONY OF CONNECTICUT" VOL. 1, PAGE 547, WAS THE FOLLOWING:

\*PROFANE SWEARING

"IT IS ORDERED AND BY THIS COURTE DECREED, THAT IF ANY PERSON WITHIN THIS JURISSDICTION SHALL SWEARE RASHLY AND VAINELY, EITHER BY THE HOLY NAME OF GOD, OR ANY OTHER OATH; AND SHALL SINFULLY AND WICKEDLY CURSE ANY; HEE SHALL FORFEITT TO THE COMMON TREASURE, FOR EVERY SUCH SEVERALL OFFENCE, TEN SHILLINGS: AND IT SHALL BEE IN THE POWER OF ANY MAGISTRATE, BY WARRANT TO THE CONSTABLE, TO CALL SUCH PERSONS BEFORE HIM, AND VPPON JUST PROOFE TO PASS A SENTENCE, AND LEUYE THE SAID PENALTY, ACCORDING TO THE VSUALL ORDER OF JUSTICE: AND IF SUCH PERSONS BEE NOT ABLE, OR SHALL VTTERLY REFUSE TO PAY THE AFORESAID FYNE, HEE SHALL BEE COMMITTED TO THE STOCKS, THERE TO CONTINUE NOT EXCEEDING THREE HOURES AND NOT LESS THAN ONE HOURE."

THE SEVERE PANIC OF 1893 BEGAN IN THE SPRING OF THAT YEAR AND AFFECTED ALL BUSINESS. A MEMORANDUM IN THE HANDWRITING OF HENRY B. SARGENT, THEN VICE PRESIDENT, GIVES SOME INDICATION OF HOW THE PANIC AFFECTED SARGENT & COMPANY, OF NEW HAVEN. IT READS "SNORT TIME. 1893. OWING TO SCARCITY OF CURRENCY AS WELL AS QUIET TRADE, BUT PRINCIPALLY THE FORMER, RAN WORKS SHORT TIME CLOSING AUG. II (THURSDAY) FOR THAT WEEK & ON THE FOLLOWING WEEK RAN THE FIRST THREE DAYS ONLY AND CONTINUED SAME UNTIL DEC. 4, 1893, WHEN WE BEGAN TO RUN 6 DAYS & EIGHT (8) HOURS PER DAY, VIZ.: 7 A.M. TO 12 M., I P.M. TO 4 P.M." THE "REGULAR" OR NORMAL WORK WEEK WAS 6 DAYS, 10 HOURS A DAY. IN MARCH 1894 THE REGULAR WORK WEEK WAS REDUCED TO 6 DAYS, 9 HOURS A DAY.

PICTURED BELOW IS ELIZABETH SARGENT FENN (1849-1904), ELDEST CHILD OF JOSEPH BRADFORD SARGENT (1822-1907), THE FIRST WIFE OF BRUCE FENN (1857-1943), AND THE MOTHER OF RUSSELL SARGENT FENN (1887-1939). SHE WAS BORN IN GRIFFIN, GA. SHE WAS GIVEN CRAFT AS A MIDDLE NAME (HER GREAT AUNT ELIZABETH COLLIER MARRIED HUGH CRAFT), AND THAT IS THE WAY HER NAME APPEARS IN THE SARGENT GENEALOGY, BUT IN HER LATER YEARS SHE PREFERRED TO USE COLLIER AS HER MIDDLE NAME. HER FATHER CALLED HER "LIZZIE", BUT SHE WAS CALLED "LILLIE" BY MOST OF HER FAMILY. AFTER HER DEATH BRUCE FENN MARRIED IN 1908 A YOUNGER SISTER, ELLEN PAGE SARGENT (1868-1930).
