STEVIA W. SARGENT, DAUGHTER OF J. WEIR SARGENT, WROTE MOST OF THE MUSIC FOR THE JUNIOR SHOW, "HI HO FRISCO", AT MOUNT HOLYOKE ON OCTOBER 31 AND PLAYED THE MUSIC FOR THE ENTIRE SHOW, WHICH LASTED SOME TWO HOURS. THE MOUNT HOLYOKE NEWS FOR FRIDAY, NOVEMBER 6, USING THE 18TH CENTURY SPELLING OF HER SURNAME, UNDER THE HEADING "STEVIE SARGEANT REVEALS SECRET OF HER TRIUMPH ON SHOW MUSIC" PRINTED THE FOLLOWING ARTICLE: "AFTER JUNIOR SHOW, THE NAME STEVIE SARGEANT BECAME SYNONYMOUS CAMPUS-WISE WITH THE WONDERFUL SONGS INCORPORATED IN THE PRESENTATION. ALL OF MOUNT HOLYOKE IS NOW SINGING TUNES CREATED BY THIS MASTER MUSIC MAKER.

"STEVIE, AS SHE IS LESS PROPERLY BUT MORE FREQUENTLY KNOWN, WAS RESPONSIBLE IN PART FOR THE SUCCESS OF ALL SHOW MUSIC. SOLE COMPOSER OF MANY OF THE NUMBERS, SHE HAD A HAND IN THE ARRANGE-MENT OF MOST OF THEM AS WELL AS ACCOMPANYING THE PERFORMANCE AT THE PIANO WITH MARY LOU JUDD.

"ALTHOUGH SHE STARTED PIANO LESSONS AT A VERY EARLY AGE, HER HARMONY COURSE THIS SEMESTER IS THE FIRST FORMAL TRAINING SHE HAS HAD IN COLLEGE. (INCIDENTALLY, SHE SEEMS TO SENSE A SHADOW OF

DOUBT CONCERNING HER GRADE. )

"AS SHE HAD CONTRIBUTED SEVERAL SONGS TO HER PREP SCHOOL, SHE WAS WELL PREPARED TO CONTINUE HER EFFORTS AT HOLYOKE. SAFFORD RANG WITH MUSIC DURING HER FRESHMAN YEAR; HOLYOKE, HOLYOKE WAS THE PRODUCT. HER TALENTS WERE AGAIN DIRECTED TO WRITING THE CLASS SONG IN HER SOPHOMORE YEAR. AS A JUNIOR, SHE IS SONG LEADER FOR THE FIRST TIME; HER CONTRIBUTIONS TO SHOW SPEAK FOR THEMSELVES.

"OF ALL HER ATTEMPTS, RUNNING AWAY IS AT THE TOP OF HER POPULARITY LIST AT THE MOMENT, THE JUNIOR CLASS HAVING PURCHASED THE COPYRIGHT FOR HER. THE MUSIC FOR THIS AND THE FINALE WAS WRITTEN IN JUNE, THE LYRICS ADDED IN THE LAST MINUTE RUSH BEFORE THE PUBLICATION OF THE SONG BOOK.

"UPON BEING QUESTIONED ABOUT THE METHODS OF HER APPROACH, STEVIE COMMENTED THAT MOST OFTEN THE WORDS AND MUSIC ARE COMPOSED TOGETHER. HER COMPOSITIONS ARE THE RESULT OF JUST HITTING UPON

SOMETHING AND WORKING IT OUT'.

"ALONG WITH HER LOVE OF MUSIC AS AN EXCELLENT METHOD OF EXPRESSION, STEVIE ENJOYS TWO PIANO WORK: PLAYING WITH MAY LOU FOR SHOW WAS SHEER PLEASURE FOR HER. LAST YEAR SHE PERFORMED OVER WMHC AND WOULD NOW LIKE TO TURN TO MORE SERIOUS COMPOSING, PERHAPS THE CLASSICAL WHICH SHE HAS NEGLECTED FOR SEVERAL YEARS.

"ONE OF HER PET OBJECTIONS IN THE FIELD IS THE PLACING OF MUSIC INTO DEFINITE CATEGORIES AS TO ITS MERIT. ACCORDING TO ONE WHO DOESN'T APPROVE OF RULES AND REGULATIONS IN THE FIELD, MUSIC IS GOOD IF IT SOUNDS WELL TO THE PERFORMER AND IF IT IS SATISFACTORY IN TERMS OF THE AIM OF THE COMPOSER. THINGS THAT ARE GREAT ARE GREAT BECAUSE PEOPLE LIKE THEM FOR WHAT THEY ARE, " SHE SAID.

"STEVIE, WHO INSISTS THAT SHE CAN'T READ MUSIC VERY WELL, IS A SOCIOLOGY MAJOR. HER BIG DREAM IS TO COMBINE HER TRAINING IN HUMAN RELATIONS WITH HER APPRECIATION OF MUSIC. EVEN IF NOTHING COMES OF IT AS A CAREER, THOUGH, SHE WILL NEVER GIVE IT UP. IT IS TO HER 'A WONDERFUL OUTLET'."

MISS MARY E. WILLIAMSON IN HER "CRITIQUE" OF THE SHOW IN THE PAPER SAID IN PART: "ENOUGH CAN'T BE SAID ABOUT THE MUSIC-STEVIE SARGENT AND HER COMMITTEE DID AN OUTSTANDING JOB. THE MUSIC WAS EXCELLENT AND THE PRESENTATION OF INDIVIDUAL SONGS WAS GOOD. TWO MORE ENCORES IN THE LAST SCENE OF THE PLAY WERE INDICATIVE OF THE AUDIENCE APPRECIATION, AND THE FINALE NOT ONLY LOOKED GOOD. IT ALSO SOUNDED, AS IT SHOULD HAVE, FULL OF ENERGY AND SATISFACTION."

STEVIA WAS THE SONGLEADER, CHAIRMAN OF THE MUSIC COMMITTEE, AND A MEMBER OF THE SONGBOOK COMMITTEE. HER PARENTS, WE'R AND PHEBE, ATTENDED THE SHOW, WHICH STEVIA SAID WAS "OPEN ONLY TO THE COLLEGE AND PARENTS OF COMMITTEE HEADS AND LEADS. THIS YEAR WE HAD ONLY ABOUT THREE WEEKS OF RE-HEARSALS. THE PLAY LASTED ABOUT 2 HOURS, AFTER WHICH THERE WAS MUCH TRADITIONAL SINGING BACK AND FORTH AMONG THE 'SISTER' CLASSES." HER ADDRESS THIS YEAR IS MEAD HALL, MT. HOLYOKE COLLEGE, SOUTH HADLEY, MASS.

MARGARET SARGENT LIE-NIELSEN, DAUGHTER OF ROBERT L. FISHER AND OF ATLEE DOWNS SARGENT, WROTE TO YE EDITORS ON OCTOBER 26 THAT ON THE IST OF NOVEMBER SHE AND LEE, HER HUSBAND, PLANNED TO LEAVE MICHIGAN FOR FLORIDA, STOPPING OFF IN BRYN MAWR TO SEE HER FAMILY AND IN GEORGIA, WHERE HER STEPSON JOHAN, WHO WAS WITH THEM ALL SUMMER, HAS BEGUN HIS LAST YEAR IN THE AGRICULTURAL HIGH SCHOOL. THE VOLUMINOUS DIARY OF GEORGE HENRY SARGENT (1828-1917), COVERING THE PERIOD FROM MAY 1, 1851, TO JANUARY 10, 1853, BEGINS IN BROOKLYN, N.Y., WHERE HE WAS THEN LIVING (OR VISITING) THE FAMILIES OF HIS BROTHER, JOSEPH BRADFORD SARGENT (1822-1907), AND HIS SISTER, SOPHIA SARGENT BOGGS (1821-1909), WHO HAD JUST MOVED FROM NEW YORK. 24 CLIFF STREET WAS THE ADDRESS IN NEW YORK OF J.B.'S STORE. TOM LEWIS REFERS, YE EDITOR BELIEVES, TO JAMES THOMAS LEWIS (1827-1908), ELDER BROTHER OF ELIZABETH COLLIER LEWIS SARGENT (1829-1874), WIFE OF J.B. AT GRIFFIN, GA., WAS HER OLD HOME. DINNER WAS THE MIDDAY MEAL.

"BROOKLYN, N.Y., THURSDAY, MAY IST 1851 - THE WEATHER, OF TODAY, HAS UPON THE WHOLE BEEN QUITE PLEASANT AND AGREEABLE. THE MORNING WAS CLOUDY, TILL ABOUT TEN O'CLOCK, WHEN THE CLOUDS CLEARED AWAY AND LEFT PLEASANT SUNSHINE WITH A MILD AND GENIAL ATMOSPHERE. THIS HAS BEEN A BUSY DAY IN N.Y. AND IN BROOKLYN, A DECIDEDLY MOVING DAY, FOR EVERYTHING AND EVERYBODY SEEMED TO BE MORE ON THE MOVE

THAN USUAL.

"WE BEGAN TO MOVE ABOUT II O'CLOCK AND THE SUN HAD SET THIS EVENING BEFORE THE LAST, THE SIXTH, LOAD OF GOODS WAS BROUGHT OVER HERE. I HAVE BEEN HERE SINCE THE FIRST LOAD CAME OVER, THIS MORNING, TO RECEIVE THE GOODS AS THEY CAME AND ATTEND TO THEIR DISPOSAL.

"IN FRONT OF US IS A HOUSE SURROUNDED BY A BEAUTIFUL GARDEN IN WHICH ARE MANY TREES, WHICH TAKEN TOGETHER WITH THE ROWS OF TREES ON OUR SIDE AS WELL AS ON THE OPPOSITE SIDE OF THE STREET, GIVES US A SCENE NOT A LITTLE LIKE THAT ENJOYED AT A COUNTRY RESIDENCE. WITH THE CONVENIENCES OF THE CITY. WE SEEM TO ENJOY THE BEAUTIES OF THE COUNTRY. WHAT A SLESSINGTREES ARE!! OUR HOUSE HERE FRONTS TO THE

RISING SUN.

"BRADFORD AND FAMILY ARE TO OCCUPY HALF OF THE HOUSE ON THEIR RETURN FROM THE SOUTH AS THEY

"BORSE CHESTNUT, MAPLE, POPLAR, ELM, LIME AND CHERRY TREES ARE IN FRONT AND AROUND US. WE ARE ABOUT A THIRD OF A MILE FROM FULTON FERRY."

\*BROOKLYN. FRIDAY, MAY 2ND, 1851. FAIR. QUITE A FINE DAY GENERALLY.

"HAVE BEEN AT 24 CLIFF ST. NEARLY ALL DAY, TAKING LESSONS FROM BROTHER J.B. CONCERNING HIS BUS INESS.

"WE ALL - J.B. TOM LEWIS AND SELF - DINED TOGETHER AT ROGERS SALOON, WHERE J.B. GENERALLY TAKES HIS DINNERS.

"Spent the eve. Here at home. Mr. Boggs and self have been arranging furniture here, some

"IT WILL BE SOME LITTLE TIME BEFORE WE GET COMFORTABLY SETTLED AS THE HOUSE IS TO UNDERGO SOME REPAIRS, BESIDES MUCH CLEANING.

"BROTHER J.B. AND FAMILY LEAVE TO-MORROW FOR CHARLESTON AND THE 'SOUTH'."

"J.B. AND SELF WERE QUITE BUSY TILL ABOUT 2 O'CLOCK THIS P.M. IN ARRANGING BUSINESS AFFAIRS.

HE GAVE ME 'POWER OF ATTY.' AT THE '7TH WARD BANK' WHERE HE DOES HIS BUSINESS AND ALSO A GENERAL POWER OF ATTY. " WE DINED AT ROGER'S EATING HOUSE-AS YESTERDAY.

"THE WHOLE FAMILY - J.B.'S - TOOK THEIR DEPARTURE AT PRECISELY 4 O'CLOCK THIS P.M. IN THE

STEAMSHIP SOUTHERNER , FOR CHARLESTON.

"THEY EXPECT TO REMAIN IN C. ONLY A FEW DAYS, THEN THEY WILL PROCEED TO GRIFFIN THROUGH AUGUSTA. FROM GRIFFIN J.B. WILL GO TO MOBILE, N. ORLEANS, AND ANY OTHER PLACE WHERE HE THINKS THERE WILL BE A POSSIBILITY OF SELLING CARDS. EVENING AT HOME."

DANIEL WHITTEMORE (1633-1683), ANCESTOR OF MOST OF US, WAS BAPTIZED IN HITCHIN, ENGLAND, JULY 31, 1633, THE SON OF THOMAS WHITTEMORE (1593-1661) AND HIS THIRD WIFE, HANNAH CHAWKLEY. DANIEL'S GRANDSON. DANIEL, WAS THE MATERNAL GRANDFATHER OF JOSEPH SARGENT (1757-1787). HE CAME TO AMERICA WITH HIS PARENTS AND THEIR THREE OTHER CHILDREN. NONE OF THE THREE CHILDREN OF THOMAS BY HIS FIRST TWO WIVES CAME TO THIS COUNTRY, BUT THOMAS AND HANNAH HAD SIX MORE CHILDREN BORN IN AMERICA. THOMAS WAS THE NAME OF DANIEL'S OLDER HALF-BROTHER (WHO REMAINED IN ENGLAND) AND WAS ALSO THE NAME OF ONE OF HIS YOUNGER BROTHERS. DANIEL MARRIED MARCH 7, 1662, MARY MELLINS, DAUGHTER OF RICHARD, WHO OUTLIVED HER HUSBAND BY SOME TEN YEARS. DANIEL DIED IN MALDEN, MASS., MAY 11, 1683, SUDDENLY, AS HIS WILL WAS NOT MADE UNTIL THE DATE OF HIS DEATH. IT WAS A NUNCUPATIVE OR ORAL WILL, LEAVING HIS WIFE ONE THIRD OF HIS ESTATE DURING HER LIFE; HIS ELDEST SON DANIEL (OUR FORBEAR) TO HAVE THREE OF FIVE PARTS OF THE MEADOW. HIS NAME IN THE RECORDS WAS ALSO SPELLED WHITAMOR, WHITAMORE, WHITAMO WHITEMORE. HIS ESTATE WAS INVENTORIED FOR 4234.5. ACCORDING TO HIS WILL HE HAD NINE CHILDREN. MARCH 1, 1658, HE WAS LISTED AS BEING READY TO ACCEPT A PORTION OF THE COMMON LANDS ON THE MYSTIC SIDE. HE WAS SUMMONED AS A WITNESS MAY 23, 1661, IN A CASE ABOUT GRAZING COWS. THE CONSTABLE POSTED JUNE 15, 1669, THE FOLLOWING PETITION: "DANIEL WHITTAMORE, BEING ONE OF YE LISTED SOULDIERS IN THE FOOT COMPANY, HATH BY SUFFICIENT TESTIMONY DECLARED HIS INABILITY TO ATTEND THE COMPANY ANY LONGER, BY REASON OF A CONTINUED DISTEMPER IN HIS HEAD. WHICH I LEAVE TO THE CONSIDERATION OF THE HONOURED COUNTY COURT NOW SITTING AT CHARLESTOWNE." IN THE OCTOBER 1670 TERM OF COURT IN CHARLESTOWN DANIEL WON A JURY VERDICT OF 43.5 PLUS COSTS OF COURT OVER HIS YOUNGER BROTHER SAMUEL. IT SEEMS THAT SAMUEL HAD SPENT THE WINTER AT DANIEL'S HOUSE AND HAD WINTERED HIS HORSE IN DANIEL'S BARN. DANIEL THOUGHT THAT SAMUEL'S CUTTING WOOD AND HAULING IT FOR HIM WAS NOT ENOUGH RECOMPENSE FOR A WINTER'S LODGING AND FEEDING, SO HE SUED FOR MORE AND WON IT. REFERENCE: NEW ENGLAND HISTORICAL AND GENEALOGICAL REGISTER VOL. 106 (1952). PP. 36 & 37;

THE CONNECTICUT GAZETTE, A WEEKLY NEW HAVEN NEWSPAPER, PRINTED IN ITS ISSUE OF SATURDAY, NOVEMBER 29, 1755, THE FOLLOWING REGARDING THE PUNISHMENT OF A LETTER, THE NEWS DATED MILFORD, CONNECTICUT, NOVEMBER 21:

"AFTER PERUSING A FALSE AND SCURRILOUS LETTER, PRINTED AT NEW-YORK, SIGNED EDWARD COLE, 1T WAS THO T PROPER, THAT THE SAME SHOULD BE PUBLICKLY WHIPT, AS TENDING TO BEGET ILL-WILL, AND BREEDING A DISUNION IN THE SEVERAL GOVERNMENTS IN AMERICA, THE CONTRARY OF WHICH, AT THIS TIME, AND PRESENT SITUATION OF OUR AFFAIRS, IS MUCH WANTED: ACCORDINGLY IT WAS HERE, AT 4 OF THE CLOCK THIS AFTERNOON, AFTER PROPER NOTICE BY BEAT OF DRUM, PUBLICKLY WHIPT, ACCORDING TO MOSES'S LAW, FORTY STRIPES SAVE ONE, BY THE COMMON WHIPPER, AND THEN BURNT.
