OFFERING FOR SALE (1) GROCERIES, (2) LADJES' SHOES, (3) SADDLES, (4) BACON, FLOUR AND MEAL, AND (5) MISSES' (MISSPELT "ISS'S") AND CHILDREN'S SHOES.

SEATON G. BAILEY OF GRIFFIN, SON OF MARY EMMA (TINY) HAMMOND BAILEY, WAS SHOWN A COPY OF THIS NEWSPAPER BY A FRIEND, AND WITH A HISTORIAN'S INSTINCT HAD COMPLETE PHOTOSTATS MADE OF ITS PAGES, HINGED THEM TOGETHER, AND SENT THEM TO YE GRATEFUL EDITOR. IN HIS LETTER OF JANUARY 13 HE STATED THAT THE TOWN OF GRIFFIN WAS CHARTERED IN 1840, AND ALSO CALLED ATTENTION TO THE ADVERTISEMENT ANNOUNC-ING THE ORGANIZATION OF THE SOUTHERN MUTUAL INSURANCE COMPANY WITH "OFFICE AT THE COUNTING ROOM OF H.J. & J.B. SARGENT, CORNER OF BROADWAY AND NEW ORLEANS STREETS, GRIFFIN, GA." ONE OF THE DIRECTORS NAMED WAS C. LEWIS (J.B. SARGENT'S FATHER-IN-LAW) AND ANOTHER WAS H.J. SARGENT, WHO WAS ALSO ASSISTANT SECRETARY. SEATON WROTE: "THESE TWO STREETS STILL EXIST, THOUGH IT WOULD NOT BE POSSIBLE, TODAY, TO LOCATE THE EXACT SITE OF THE OLD, BRICK BUILDING, MENTIONED IN ONE OF THE SARGENT & CO. ADVERTISEMENTS. THE SOUTHERN MUTUAL INSURANCE COMPANY IS STILL IN OPERATION, THOUGH ITS OFFICES WERE MOVED TO ATHENS, GEORGIA, MANY YEARS AGO."

Sargent & Co. was the store of the brothers Harrison Jones Sargent (1819-1903) and Joseph BRADFORD SARGENT (1822-1907). THE LATTER, WHO IN 1839 BEGAN HIS EMPLOYMENT IN A DRY GOODS STORE IN BOSTON, IN 1842 AFTER THE DEATH OF HIS EMPLOYER, E.F. NEWHALL, JOINED HIS ELDER BROTHER IN HIS RETAIL STORE IN GRIFFIN. YE EDITOR DOES NOT KNOW WHEN H.J. SARGENT STARTED HIS STORE, BUT HE WAS AWAY FROM THE BUSINESS DURING THE MEXICAN WAR, WHICH BEGAN IN MAY 1846, THE PEACE TREATY BEING SIGNED FEBRUARY 2, 1848, AND IN WHICH HE ADVANCED TO BE AN ARMY CAPTAIN. ON JANUARY 17, 1848, J.B. SARGENT, THEN 25, WAS MARRIED IN GRIFFIN TO ELIZABETH COLLIER LEWIS, AGED 19. THEIR ELDEST DAUGHTER WAS BORN IN GRIFFIN May 7, 1849. IN THAT MONTH OR IN JUNE J.B. SARGENT PULLED UP STAKES AND MOVED HIS FAMILY TO NEW YORK "WITH ITS GREATER OPPORTUNITY" AS HIS REASON, ACCORDING TO HIS ELDEST SON. JOSEPH DENNY SARGENT (1787-1849), FATHER OF THE BROTHERS, DIED IN LEICESTER, MASS., MAY 24, 1849. THIS DEATH MAY HAVE BEEN AN IMPORTANT REASON WHY J.B. SARGENT RETURNED TO THE NORTH, FOR HE PROMPTLY WENT TO LEICESTER AND PURCHASED HIS FATHER'S HALF INTEREST IN J.D. SARGENT & CO., MANUFACTURERS OF HAND CARDS, AND THEN ESTABLISHED HIMSELF AS A MERCHANT IN NEW YORK.

JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR'S GENERATION, WAS A PROLICIC LETTER WRITER. THE COPIES OF HIS LETTERS, ALMOST INVARIABLY IN LONGHAND, IN HIS LETTER PRESS BOOKS MAKE INTERESTING READING. HIS LETTER BOOK COVERING THE PERIOD MAY 25, 1891, TO JULY 31, 1903, (OVER-LAPPING IN DATES ANOTHER LETTER BOOK) HAS ON IT A LABEL READING: "J.B.S.'S PERSONAL, MAYORALTY, HOUSE BOOK, ESTATES OF MRS. BOGGS AND OF H.J.S. BEGAN MAINLY FOR SELF PROTECTION IN OFFICIAL DUTY TO KEEP PRIVATE RECORD OF MY LETTERS & ACTS AS MAYOR." HERE IS ONE OF MANY HE WROTE TO E.G. STODDARD, THE CITY TREASURER OF NEW HAVEN. MR. STODDARD WAS AT THAT TIME PRESIDENT OF THE NEW HAVEN COUNTY NATIONAL BANK, AND AFTER THE LATER MERGER OF THIS BANK AND TWO OTHERS INTO THE NEW HAVEN BANK, N.B.A., WAS PRESIDENT OF THE LATER INSTITUTION.
