THE FOLLOWING FROM THE DIARY OF LIEUT. COL. JOSEPH SCRANTON TATE, JR., SON OF ALICE SARGENT TATE, IS A CONTINUATION OF THE ACCOUNT IN SARGENTRIVIA OF SEPTEMBER 21 OF A BOMBING MISSION ON NOVEMBER 9, 1942, TO THE GERMAN SUBMARINE BASE AT ST. NAZAIRE, FRANCE. HE WAS A FIRST LIEUTENANT AND PILOT OF A B-24 LIBERATOR.

"THIS LEFT JARVIS AND FRANK WITHOUT A LEADER AND SO JARVIS JOINED UP IN DIAMOND UNDER THE MAJOR'S FLIGHT AND FRANK DROPPED BACK INTO THE 44TH. JO JO DROPPED HIS INTO THE SHEDS AND THEN OUR FLIGHT CAME OVER. BENNIE LET HIS FLY AND FLICKED INTO A RIGHT TURN. I LET MINE GO AND THEN STEW SENT HIS DOWN TO JOIN OURS. AT JUST ABOUT THIS TIME I GLANCED AT MY LEFT AND SAW THE 44TH ABOUT TWO MILES OUT COMING IN FROM A DIFFERENT DIRECTION. THAT ONE GLANCE ALMOST PROVED FATAL FOR ME — AND IT WOULD HAVE HAD IT NOT BEEN FOR THE FACT THAT THERE WERE NO FIGHTERS PRESENT AT THAT TIME — FOR BENNIE'S TURN WAS SHARPER THAN I HAD ANTICIPATED AND I DROPPED OUT OF FORMATION ABOUT FIVE HUNDRED YARDS. I ALMOST FLIPPED OVER ON MY BACK AS I TURNED TO FOLLOW BENNIE AND FOUND THAT STEW HAD DONE THE SAME THING. I WAS FLYING ALMOST STRAIGHT DOWN WITH FULL THROTTLE AND SUPER CHARGERS AND GOING TO BEAT HELL. I WAS INDICATING BETTER THAN 250 AT ONE TIME AND HAVING THE TIME OF MY LIFE DODGING FLAK. I WAS DRIVING DOWN THE SKY HAPPY AS A LARK. I SAW THREE BURSTS OF HEAVY BLACK RIGHT ABOVE BENNIE'S COCKPIT AND I REALLY THOUGHT THAT HE HAD TAKEN THE ROD. IT LOOKED TO ME AS IF THE ONLY WAY THAT THEY COULD HAVE BURST UP THERE WAS TO COME RIGHT THROUGH THE SHIP. I WAS WRONG THOUGH, THANK THE LORD! AL GOT A FEW NICKS AND A HOLE THROUGH ONE WING. WE PASSED OVER A COUPLE OF BOATS AND THE GUNNERS LET FLY AT THEM IN THE HARBOR. FAINTLY YOU COULD MAKE OUT THE CREWS AND WORKMEN SCURRYING FOR SHELTER AWAY FROM THE SUB PENS AND LOCKS, LIKE ANTS BEFORE A FLOOD. ONE SMALL STEAMER JUST OUTSIDE THE BREAK-WATER WAS CIRCLING IN TIGHT CIRCLES, LEAVING BEHIND HIM A FURIOUS WAKE OF WHITE FOAM. THE SUN WAS BRIGHT AND CLEAR AND WE COULD SEE THE B-17S BACK THERE CATCHING HELL FROM THE VERTICAL CLOUDS OF FLAK

WHICH THE JERRIES FLUNG UP AT THEM. OUT TO THE RIGHT I COULD SEE ANOTHER GROUP OF 17S COMING IN LOW AND DUE TO CATCH HELL AGAIN. IF A B-24 HAS EVER DONE ANY MORE VIOLENT FLYING, I DON'T KNOW WHEN IT WAS, BECAUSE I KICKED BOF JR. FROM ONE CORNER OF THE SKY TO THE OTHER. WHEN A BURST OF FLAK CAME TO THE RIGHT OF US WE WOULD SLIDE SWERVE AND SLIP TO THE LEFT AND THEN RIGHT BACK AGAIN, AS ANOTHER BURST WOULD FOLLOW US TO THE LEFT. I WAS TREMENDOUSLY EXHILARATED. I FELT LIKE I COULD DO ANYTHING. WE HIT THE TARGET AT 14:12 AND IN NOTHING FLAT WERE DOWN AT 6000 AND HEADED OUT TO SEA. I WAS AS PROUD OF MYSELF AS IF I HAD JUST DEFEATED THE WHOLE GERMAN ARMY. I KEPT THINKING OF HOW THOSE ANTI-AIRCRAFT GUNNERS MUST HAVE HAD TO WORK TO KEEP ANYWHERE NEAR US. FIRST OF ALL THEY HAD BEEN WORKING ON THE 17S BELOW US AT 8000. THEN TO GET US THEY HAD TO SHIFT UP TO 18,000 AND JUST THEN — AFTER WE HAD PULLED A SNEAK PLAY ON GETTING IN ON THEM UNNOTICED — WHILE THEY BLASTED THE 91ST — WE SLIPPED OUT JUST AS THEIR BARRAGE BLASTED THE SKY WHERE WE HAD BEEN AND ANOTHER GROUP OF 17S, THE 301ST SLIPPED IN UNDERNEATH US, AND THEY HAD TO CHANGE ALTITUDE, — NOT ONLY THIS BUT IF ALL OF US WERE TAKING AS VIOLENT EVASIVE AS I WAS, THEY WERE REALLY GOING CRAZY. THOSE BEAUTIFUL CLOUDS REACHED UP FOR US AT ABOUT 2000' AND AFTER PASSING BACK OVER SOME SMALL ISLANDS, ON WHICH I SAW SOME GUN POSITIONS WHICH DID NOT OPEN FIRE ON US, WE HEADED FOR THE GRATEFUL COVER OF THOSE CLOUDS AND DROPPED BACK DOWN TO ZERO ALTITUDE AND HEADED FOR HOME IN OUR ROUNDABOUT WAY. I LET TOMMY FLY MOST OF THE WAY BACK AND AFTER MEETING 36 TRANSPORT PLANES HEADED OUT TO SEA WE HIT THE VERY WESTERN TIP OF ENGLAND AND WERE SOON DOWN AT DAVIDSTOWE, AFTER FLYING A 14 SHIP RIGHT ESCHELON AND MISSING THE FIELD ONCE, WE GOT IN UNDER SLIGHTLY TRYING TRAFFIC CONDITIONS, AND FINALLY GOT TAXIED INTO SOME NEW TAXI SPOTS AFTER 5:55 FLYING DURING WHICH TIME WE COVERED ABOUT 1100 MILES OR MORE. J. MURPHY HAD FLOWN IN IN THE OLD BOF JUST IN TIME TO WATCH US GO AND MISS IT HIMSELF. WE HAD A GOOD SUPPER WITH THE IODINE WATER THEY SERVE HERE — BENNIE R AND I HAD TWO OF THEM A PIECE BY SITTING AT A NEW TABLE AFTER OUR FIRST MEAL. I STAYED A LITTLE AFTER SUPPER — ARRANGED TO HAVE OUR GUNS CLEANED AND THE SHIP GASSED AND GUARDED AND B-SED WITH MAX SULLIVAN, FRITZ, TOMMY ROLL AND DUMB JARVIS AND OLD JOHN NITSCHKE. THEN I SLOGGED MY WEARY WAY HOME THROUGH THE MUD TO MY HUT AND BEGAN WRITING THIS. THE RAID WAS A COMPLETE SUCCESS FROM MY POINT OF VIEW. ALL BUT ONE 328TH SHIP HIT THE TARGET ALTHOUGH ONE HQ SHIP MISSED AND MOST OF THE 44TH DID TOO. NO ONE WAS INJURED AT ALL AND THE FLAK MADE ALMOST NEGLIGIBLE IMPRESSION. WE HAD A FEW STRAY SCRATCHES AND GASHES AND A LIGHT BURST IN THE BOMB BAY AND THAT WAS ALL. I AM GLAD TO BE BACK SAFE AND SOUND FOR YOU MARGIE."

FRANCES TOUGH (B. PROB. 1595-97, D. 1673) WAS THE MAIDEN NAME OF OUR ANCESTRESS WHO MARRIED EDWARD STEBBINS (OR STEBBING) IN ENGLAND, PROBABLY IN 1629. HER FAMILY NAME WAS NOT KNOWN TO YE EDITOR WHEN THE GENEALOGICAL CHART WAS PRINTED IN SARGENTRIVIA OF MARCH 19, 1952, SHOWING SOME OF THE FOREBEARS OF ELIZABETH COLLIER LEWIS SARGENT (1829-1874), AND OF LAURA FRANCES LEWIS HAMMOND (1835-1908).

THE AMERICAN GENEALOGIST OF OCTOBER 1954, PAGES 193-212, PUBLISHES THE RESULTS OF RESEARCHES OF JOHN INSLEY CODDINGTON, OF WASHINGTON, D.C., AND MRS. FLORENCE E. SKILLINGTON, OF LEICESTER, ENGLAND. FRANCES TOUGH WAS "PROBABLY BORN ABOUT 1595-97", THE DAUGHTER OF RALPH TOUGH OF BURROUGH (OR BURROW)-ON-THE-HILL, CO. LEICESTER, ENGLAND. SHE WENT TO LONDON AS A YOUNG WOMAN AND THERE MARRIED, 1ST, NOVEMBER 26, 1617, SAMPSON CHESTER, ALSO OF LEICESTERSHIRE, AT THAT TIME A CITIZEN AND MERCHANT TAILOR OF LONDON, WHOSE OLDER BROTHER MARRIED A SISTER OF THE REV. THOMAS HOOKER, FOUNDER OF HARTFORD, CONN. SAMPSON AND FRANCES (TOUGH) CHESTER HAD FOUR CHILDREN. AFTER HIS DEATH SHE MARRIED, 2D, FEBRUARY 25, 1627/28, THOMAS SMITH AT BERMONDSEY, CO. SURREY, ENGLAND. THE LATTER DIED SOON AFTER, WITH NO RECORD OF ANY CHILDREN. SHE MARRIED, 3D, EDWARD STEBBING (LATER SPELLED STEBBINS) PROBABLY IN 1629, BUT WHERE IN ENGLAND HAS NOT BEEN DISCOVERED. HE CAME TO NEW ENGLAND BEFORE MARCH 29, 1632, TO NEW TOWN (LATER CAMBRIDGE) IN MASSACHUSETTS BAY COLONY. "WHETHER HE BROUGHT HIS WIFE AND CHILDREN WITH HIM IS NOT KNOWN, BUT IT IS POSSIBLE THAT FRANCES AND HER TWO LITTLE STEBBING DAUGHTERS REMAINED IN ENGLAND FOR A WHILE, AND FOLLOWED EDWARD AT A LATER DATE. . . . HIS DWELLING HOUSE IN CAMBRIDGE WAS AT THE SOUTHWEST CORNER OF WATER (LATER DUNSTER) STREET AND BRAINTREE OR HARVARD STREET (LATER MASSACHUSETTS AVENUE); THAT IS, HE LIVED ON WHAT IS NOW HARVARD SQUARE, OPPOSITE THE YARD." THEIR ELDER DAUGHTER MARY (ABT. 1630-1657), OUR ANCESTRESS, MARRIED WALTER GAYLORD (ABT. 1626-1689), AND WAS THE MOTHER OF JOANNA GAYLORD (1652/3-1699) WHO MARRIED JOHN PORTER (1651-1699).

THE NAME OF FRANCES TOUGH'S MOTHER HAS NOT BEEN DISCOVERED, BUT RALPH, HER FATHER, WAS THE SECOND SON OF THOMAS (D. 1586) AND SUSAN TOUGH (D. 1592). THERE IS SOME EVIDENCE, BUT NOT CONCLUSIVE, THAT THOMAS WAS THE SON OF WILLIAM (D. ABT. 1542/3) AND JOANNA TOUGH AND THE GRANDSON OF WILLIAM AND AGNES TOUGH. THOMAS' WILL, EXECUTED MAY 20, 1586, READS IN PART: "ITM I GIVE TO SUSANE MY WIFE THE THIRD OF ALL MY LANDS IN THE FIELDS AND A THIRD OF ALL COMMODITIES THERETO BELONGING AND SHE TO HAVE THE CHAMBER ON THE ENTRY AND EAST END OF THE YARD TO DWELL DURING HER LIFE AND ROOM IN THE HALL CHIMNEY TO DO ANYTHING ALSO I BEQUEATH TO MY SAID WIFE ONE BRASS POT BEING THE GREATEST I HAVE BUT ONE ITM I GIVE UNTO HER TWO PAIR OF THE GREATEST PEWTERS AND TWO LATTYNE CANDLESTICKS AND ONE LATTYNE CHAFFING-DISH WHICH SHE WILL CHOSE ALSO I GIVE UNTO HER ONE LOOME AND ONE KYMNEL AND ONE COFFER WHICH WAS HER OWN BEFORE I MARRIED HER AND V S. [5 SHILLINGS] TO BUY HER WOOD AND ONE BEDSTEAD AND ALL FURNITURE FOR THIS BED BEING THE BED THAT STANDETH IN THE CHAMBER WHERE I LIE MYSELF."

THE CASH BOOK OF SARGENT & COMPANY, NEW HAVEN, RECORDS A PAYMENT MADE MARCH 23, 1868, TO OR FOR PAT MCSHARA, JR., OF THE BLACKSMITH'S DEPARTMENT OF \$5 "TO HIS DAD", AND ONE ON MARCH 25 TO OR FOR DAN MAHAR OF THE IRON FOUNDRY OF \$1 "TO HIS MA". J.B. SARGENT WAS ALWAYS READY TO HELP THE EMPLOYEES TO SEND SOME OF THEIR SAVINGS TO THEIR PARENTS "IN THE OLD COUNTRY". THESE ITEMS APPEAR TO BE OF THAT NATURE.
